



Fantasy Contests - 2019

- Online Game
- Players assemble virtual teams of real players in a professional sport
- Teams compete based on the actual statistical performance of the real players
- Contests can be season long or played across shorter periods of time, such as a single week of a season



Sports Gaming - 2023

- Sports gaming is the business of accepting wagers on sporting events.
- Sporting events include:
 - Any professional sport or athletic event
 - Any collegiate sport or athletic event
 - Any Olympic or international sports competition event
 - Any motor race event
 - Any esports event (video game competition)
 - Any other special event the commission authorizes
 - The individual performance statistics of athletes
- Sporting events do NOT include:
 - An event for K-12 school students




- The Commission is a law enforcement agency

 - 11 Gaming Agents









Pickaway County shop raided for gambling machines

Following complaints from residents, state and local authorities raided a business and a house in Pickaway County this afternoon and seized records and slot machines as part of a suspected illegal gambling operation.

Agents with the Ohio Casino Control Commission, the Ohio Bureau of Criminal Investigation and deputies and detectives from the Pickaway County sheriff's office seized 143 gambling machines, cash and documents from Spinners, a business at 24753 Rt. 23 in Circleville, said Jessica Franks, spokeswoman for the commission.

Authorities also raided the home of the business's owner, Stephen Cline, 68, at 14270 Walnut Pike Creek in Ashville. He has not been criminally charged.

But he could be, if the investigation shows that he was, in fact, giving out cash prizes. In Ohio, the charge of illegal gambling is a fifthdegree felony.

- Warrants served on 165 locations
- 7,490 + illegal slot machines seized/disabled
- Approx. \$7.5 million in cash seized on site

PROBLEM GAMBLING SERVICES

Problem Gambling Index

Questions:

- 1) Have you bet more than you could really afford to lose?
- 2) Have you needed to gamble with larger amounts of money to get the same feeling of excitement?
- 3) When you gambled, did you go back another day to try to win back the money you lost?
- 4) Have you borrowed money or sold anything to get money to gamble?
- 5) Have you felt that you might have a problem with gambling?
- 6) Has gambling caused you any health problems, including stress or anxiety?
- 7) Have people criticized your betting or told you that you had a gambling problem, regardless of whether or not you thought it was true?
- 8) Has your gambling caused any financial problems for you or your household?
- 9) Have you felt guilty about the way you gamble or what happens when you gamble?

Scoring:

0 = "Never"

1 = "Sometimes"

2 = "Most of the time"

3 = "Almost always"

Low Risk: 1-2 Moderate Risk: 3-7 Disordered Gambling: 8 or <


- GamBan Once downloaded, blocks thousands of legal and illegal websites and apps worldwide
