### **HOUSE BILL 148 PROPONENT TESTIMONY SENATE WAYS AND MEANS COMMITTEE MARCH 24, 2026**

Chairman Blessing, Vice Chairman Roegner, Ranking Member DeMora and members of the committee, my name is Tony Seegers and I appreciate the opportunity to present proponent testimony for HB 148 on behalf of my client, the Ohio Pet Fund.

I have a personal connection to the Ohio Pet Fund outside of them being a client. A little over twenty years ago, I was the senior legislative aide for the late, great, Senator Bob Schuler. That is where I had the opportunity to meet two very passionate and dedicated people, Peggy Kaplan and Julie Bertani. They had formed the Ohio Pet Fund in 2000 with the goal of ending the overpopulation of dogs and cats. Peggy and Julie came to Senator Schuler and requested he introduce a license plate bill with the proceeds going to the Fund to pay for the spaying and neutering of companion animals. Through their tireless advocacy and the determined work of Senator Schuler, the Pets license plate bill was passed into law. Since then, the Ohio Pet Fund, through its board, has given countless grants to help prepare pets for adoption, and to assist organizations that help low-income families and disabled veterans, as well as educating veterinary students about the proper veterinary care of cats and dogs.

The Ohio Pet Fund and its voluntary board have a 20 plus year history of success with their license plate and grants. For instance, in 2025, they granted over 99% of the funds they received from license plate sales the prior year for spay-neuter and education. It is important to note that many local shelters would be unable to offer spay and neutering services if it was not for the Fund. Further, the Ohio Pet Fund is very transparent about the grants awarded, listing the grant recipients and amounts on the Fund's website. I have included many of the 2025 grant awards for your convenience.

With HB 148, Ohio will be joining over a dozen states that have a tax check-off for spay-neuter. Other states, such as Oregon, offer a state tax check off as a way for citizens to donate to a 501c3 organization (Oregon Humane Society) for companion animals. Many other states offer a tax check off for 501c3

organizations like Make-A-Wish, ALS Societies and Multiple Sclerosis Societies. These funds will allow the Ohio Pet Fund to grant even more dollars to local shelters to offer spaying and neutering for low-income Ohioans.

License plate proceeds in 2024 were about \$270,000. It just doesn't go far enough when there are 200 applicants for funding. The Ohio Pet Fund does a great job of marketing and the pet plate is the second most popular plate, but the number of specialty license plates have increased tenfold from about 30 to about 300, another reason why additional income streams are necessary, such as would be provided by House Bill 148 with a voluntary tax check off, and which could double the spay-neuter fund income and save the lives of hundreds of cats and dogs. Neutered homeless pets are more likely to get adopted.
