To amend sections 4109.08, 4111.09, 4112.07, 4115.07, 4123.54, 4123.83, and 4167.11 of the Revised Code to allow employers to post certain labor law notices on the internet, was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Brent moved to amend, amendment 0375, as follows:

In line 24, after "employees" insert ".

(3) An employer that chooses to post the abstract on the employer's public web site on the internet shall ensure the abstract is accessible from the main page of the web site on which it is posted by use of not more than one link. An employer that maintains a web site for use by employees only and

that chooses to post the abstract on the internet shall ensure the abstract is accessible from the main page of the employee web site by use of not more than one link"

In line 61, after "employees" insert ".

(3) An employer that chooses to post the summary on the employer's public web site on the internet shall ensure the summary is accessible from the main page of the web site on which it is posted by use of not more than one link. An employer that maintains a web site for use by employees only and that chooses to post the summary on the internet shall ensure the summary is accessible from the main page of the employee web site by use of not more than one link"

After line 77, insert:

"A person that chooses to post the notice on the person's public web site on the internet shall ensure the notice is accessible from the main page of the web site on which it is posted by use of not more than one link. An employer that maintains a web site for use by employees only and that chooses to post the summary on the internet shall ensure the summary is accessible from the main page of the employee web site by use of not more than one link. The employer shall make the link accessible to individuals other than employees."

After line 111, insert:

"A contractor or subcontractor that chooses to post the statement on the contractor's or subcontractor's public web site on the internet shall ensure the statement is accessible from the main page of the web site on which it is posted by use of not more than one link. A contractor or subcontractor that maintains a web site for use by the contractor's or subcontractor's employees only and that chooses to post the summary on the internet shall ensure the summary is accessible from the main page of the employee web site by use of not more than one link."

After line 252, insert:

"An employer that chooses to post the notice on the employer's public web site on the internet shall ensure the notice is accessible from the main page of the web site on which it is posted by use of not more than one link. An employer that maintains a web site for use by employees only and that chooses to post the notice on the internet shall ensure the notice is accessible from the main page of the employee web site by use of not more than one link."

After line 488, insert:

"An employer that chooses to post the notice on the employer's public web site on the internet shall ensure the notice is accessible from the main page of the web site on which it is posted by use of not more than one link."

An employer that maintains a web site for use by employees only and that chooses to post the notice on the internet shall ensure the notice is accessible from the main page of the employee web site by use of not more than one link."

In line 514, after "employees" insert ". The rule shall require a public employer that chooses to post a notice on the employer's public web site on the internet to ensure the notice is accessible from the main page of the web site on which it is posted by use of not more than one link. If a public employer that chooses to post the notice on the internet maintains a web site for use by employees only, the rule shall require the employer to ensure the summary is accessible from the main page of the employee web site by use of not more than one link"

The question being, "Shall the motion to amend be agreed to?"
