INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 618 - Representative Johnson.

To amend section 4501.21 and to enact section 4503.739 of the Revised Code to create the "Chillicothe Paints" license plate.

H. B. No. 619 - Representative Lorenz.

To amend section 3501.09 of the Revised Code to authorize a board of elections to conduct meetings by video conference or any other similar electronic technology.

H. B. No. 620 - Representatives McNally, Grim.

Cosponsors: Representatives Brennan, Upchurch.

To amend section 1321.44 and to enact sections 1317.081, 1321.142, 1321.412, 1321.593, and 1321.633 of the Revised Code to prohibit financing the purchase of a dog or cat.

H. B. No. 621 - Representatives Grim, McNally.

Cosponsors: Representatives Brennan, Brownlee, Upchurch.

To amend section 956.181 and to repeal section 956.23 of the Revised Code to alter the law governing the regulation of pet stores.

Said bills were considered the first time.
