The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 47** - Representatives Williams, Santucci.

Cosponsors: Representatives Barhorst, Bird, Click, Daniels, Fischer, Gross, Hall, T., John, Johnson, King, Lorenz, Robb Blasdel, Richardson, Workman.

To amend sections 2903.41, 2905.01, 2905.02, 2905.32, and 2971.03 of the Revised Code to enact the Human Trafficking Prevention Act to increase the penalty for human trafficking of a minor or person with a developmental disability, kidnapping, and abduction.

**H. B. No. 48** - Representatives Mathews, A., Santucci.

To amend sections 5747.70 and 5747.78 of the Revised Code to modify the income tax deductions for contributions to 529 plans and ABLE accounts.

**H. B. No. 49** - Representative Claggett.

To enact sections 6120.01, 6120.02, 6120.03, 6120.031, 6120.032, 6120.033, 6120.04, 6120.05, 6120.06, 6120.07, 6120.08, 6120.09, 6120.10, 6120.11, 6120.12, 6120.13, 6120.14, 6120.15, 6120.16, 6120.17, 6120.18, and 6120.19 of the Revised Code to allow for the creation of water improvement districts.

**H. B. No. 50** - Representative King.

To enact section 5533.106 of the Revised Code to designate a portion of State Route 47 in Darke County as the "PFC John Wayne Richard Memorial Highway."

**H. B. No. 51** - Representatives Klopfenstein, King.

To enact section 5534.427 of the Revised Code to designate a portion of U.S. Route 33 in Auglaize County as the "Lt. James A. Kirkendall Memorial Highway."

**H. B. No. 52** - Representative Deeter.

To amend sections 4723.01, 4723.43, 4723.432, 4729.01, 4731.27, 4731.35, and 4761.17; to enact new section 4723.433 and section 4731.513; and to repeal sections 4723.433, 4723.434, and 4723.435 of the Revised Code to revise the law governing the practice of certified registered nurse anesthetists.

**H. B. No. 53** - Representatives Fischer, Pizzulli.

To enact section 5.295 of the Revised Code to designate February 4th as John Rankin Day, and to require a statue of John Rankin to be erected on the statehouse grounds.

To amend sections 154.01, 717.02, 4501.01, 4511.01, 4511.031, 4511.09, 4511.091, 4511.092, 4511.094, 4511.11, 4511.13, 4511.131, 4511.132, 4511.18, 4511.204, 4511.211, 4511.214, 4511.432, 4511.46, 4511.48, 4511.512, 4511.61, 4511.62, 4511.64, 4511.65, 4511.68, 4511.701, 4511.712, 4519.401, 5501.20, 5513.01, 5515.01, 5515.02, 5515.99, 5517.02, 5517.021, 5525.03, 5525.04, 5525.08, 5525.14, and 5571.01; to enact sections 4511.15, 5515.09, 5515.10, 5517.012, 5517.06, and 5525.141; and to repeal sections 4511.351 and 4511.491 of the Revised Code to make appropriations for programs related to transportation for the biennium beginning July 1, 2025, and ending June 30, 2027, and to provide authorization and conditions for the operation of those programs.

To amend sections 2127.38 and 5721.10 of the Revised Code to amend the law related to fees for the administration of a probate estate.

To enact section 5534.013 of the Revised Code to designate a portion of State Route 421 in Medina County as the "CPL David James Amheiser Memorial Highway."

**H. B. No. 57** - Representatives Jarrells, Williams.

Cosponsors: Representatives McNally, Brewer, Russo, Baker, Isaacsohn, Grim, Somani, Upchurch, Brennan, Thomas, C., Rogers, Deeter, Denson, Piccolantonio, Sigrist, Mohamed.

To enact sections 3313.7118, 3313.7119, 3314.148, 3326.62, and 3328.40 of the Revised Code regarding school policies on the administration of overdose reversal drugs.

**H. B. No. 58** - Representatives Pizzulli, Jarrells.

To amend section 5119.393 and to enact sections 5119.398, 5119.399, 5119.3910, 5119.3911, 5119.3912, 5119.3913, 5119.3914, and 5119.3915 of the Revised Code to create a certificate of need program for recovery housing residences.

**H. B. No. 59** - Representatives Fowler Arthur, Hiner.

To revise and streamline the state's occupational regulations.

**H. B. No. 60** - Representatives Humphrey, Williams.

Cosponsors: Representatives Russo, Upchurch, Lett, Brewer, Jarrells, Rogers, Brennan, Sigrist, Synenberg, Piccolantonio, Rader, Baker, Brent.

To amend section 3517.13 of the Revised Code to allow a candidate to use campaign funds to pay certain child care costs.

Said bills were considered the first time.
