**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 149** - Representatives King, Miller, K.

Cosponsors: Representatives Hall, T., Williams, Click, Gross, Ritter, Johnson, Daniels, Lear, Klopfenstein.

To amend section 5747.98 and to enact sections 1315.131, 5502.80, and 5747.87 of the Revised Code to levy a transfer fee on money transmissions, to authorize an income tax credit based on the amount of the transfer fees paid, and to name this act Ohio's Withholding Illegal Revenue Entering Drug Markets (WIRED) Act.

**H. B. No. 150** - Representatives McNally, White, E.

Cosponsors: Representatives Upchurch, Brent, Rader, Brownlee, Lett, Brennan, Mohamed, Troy, Russo, Grim, Miller, J., Somani, Jarrells, Brewer, Sims, Robinson, Cockley, Baker, Synenberg, Isaacsohn, Abdullahi, Piccolantonio.

To amend sections 4109.08, 4109.13, and 4109.99 of the Revised Code to enact the Clock Out Kids Act to require school employees to report certain minor labor law violations, to increase penalties for certain minor labor law violations, and to create the Minor Labor Law Enforcement Fund; and to make an appropriation.

Said bills were considered the first time.
