## SIXTY-SIXTH DAY

The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Claggett was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 404** - Representatives Daniels, Lorenz.

To amend section 5739.01 of the Revised Code to authorize a sales tax credit for the trade-in value of portable electronics or home appliances for another similar item.

**H. B. No. 405** - Representatives Lorenz, Daniels.

To amend section 1345.21 of the Revised Code to exclude consumer goods service contracts from home solicitation sales regulations.

**H. B. No. 406** - Representatives Deeter, Dean.

To amend sections 917.01, 917.02, 917.04, 917.07, 917.09, and 917.99 and to enact sections 917.041 and 917.042 of the Revised Code to regulate the sale of raw milk and to name this act the Farm-to-Consumer Access to Raw Milk Act.

Said bills were considered the first time.
