The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 435 - Representatives Williams, Miller, M.
Cosponsors: Representatives McClain, Deeter, Johnson.

To amend sections 3705.01 and 3705.09 of the Revised Code to require an institution to offer genetic testing to confirm paternity when a child is born to unwed parents and to name this act the Right to Know Act.

H. B. No. 436 - Representatives Ritter, Miller, K.

To enact section 5534.968 of the Revised Code to designate a portion of Interstate Route 77 in Washington County as the "Auxiliary Patrolman Earl Ulmer Memorial Highway."

H. B. No. 437 - Representatives Rader, Schmidt.

Cosponsors: Representatives Brennan, Brewer, Brownlee, Grim, Rogers, Russo, Miller, J.

To amend sections 3313.5310, 3707.58, 3707.59, 4723.24, 4723.28, 4723.99, 4730.14, 4730.25, 4730.99, 4731.22, 4731.281, and 4731.99 and to enact sections 3707.591, 4723.484, 4730.46, 4731.89, and 5164.21 of the Revised Code regarding cardiac monitoring for youth and to name the amendments and enactments by this act the Healthy Cardiac Monitoring Act.

H. B. No. 438 - Representatives Rader, Brownlee.

Cosponsors: Representatives Grim, Piccolantonio, Somani, Jarrells, Robinson, McNally, Brennan, Brent, Upchurch, Abdullahi, White, E., Isaacsohn, Synenberg, Lett, Rogers, Russo, Miller, J.

To amend sections 1731.04, 1751.01, 1751.06, 1751.12, 1751.18, 1751.58, 1751.69, 3902.50, 3922.01, 3923.57, 3923.571, 3923.85, 3924.01, 3924.02, 3924.03, 3924.033, 3924.51, and 4125.041 and to enact sections 3902.55, 3902.56, 3902.57, and 3902.58 of the Revised Code regarding health insurance premiums and benefits and to name this act the Fair Access to Medical Insurance for Local Youth and Families (FAMILY) Act.

H. B. No. 439 - Representatives Rader, Brennan.

Cosponsors: Representatives Troy, Lett, McNally, Brownlee, Robinson.

To amend sections 1509.03, 1509.22, 1509.222, 1509.223, 1509.224, 1509.33, and 1509.99 and to repeal section 1509.226 of the Revised Code to expressly prohibit the surface application of brine from oil and gas wells on roads.

H. B. No. 440 - Representatives Deeter, Stewart.

To amend sections 4723.091, 4723.092, and 4723.28 of the Revised Code to revise the law governing the Board of Nursing and criminal records check results and to declare an emergency.

H. B. No. 441 - Representatives Stewart, Mathews, A.

Cosponsor: Representative Williams.

To amend section 2305.11 of the Revised Code to provide that for purposes of the one-year limitations period for libel or slander, the cause of action starts from publication of the libelous matter or when the slanderous words were spoken, regardless of when the aggrieved party discovered the libelous matter or slanderous words.

H. B. No. 442 - Representative Isaacsohn.

To amend section 3521.01; to enact new sections 3521.011, 3521.012, 3521.013, 3521.014, 3521.015, 3521.016, 3521.017, 3521.018, 3521.019, 3521.0110, 3521.0111, 3521.0112, 3521.0113, 3521.0114, and 3521.0115; and to repeal sections 3521.011, 3521.012, 3521.013, 3521.014, 3521.015, 3521.016, 3521.017, 3521.018, 3521.019, 3521.0110, 3521.0111, 3521.0112, 3521.0113, 3521.0114, and 3521.0115 of the Revised Code to designate new congressional district boundaries pursuant to Article XIX of the Ohio Constitution.

Said bills were considered the first time.
