INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 580 - Representatives Barhorst, King.

To enact section 5534.857 of the Revised Code to designate a portion of State Route 47 in Shelby County as the "PFC Francis Guillozet Memorial Highway."

H. B. No. 581 - Representatives Lett, Odioso.

To amend section 5163.093 of the Revised Code regarding eligibility for the Medicaid Buy-In For Workers With Disabilities Program and the Ohio WorkAbility Program.

To amend sections 4717.01, 4717.12, 4717.24, and 4717.30 of the Revised Code regarding embalmers, funeral directors, and crematories.
