INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 413 - Representatives Young, Peterson.

To amend sections 113.70, 113.71, 113.72, 113.73, 113.74, 113.75, 113.76, and 5501.521; to enact new section 113.77 and sections 113.80, 113.81, 113.82, 113.83, and 113.84; and to repeal section 113.77 of the Revised Code to create the Ohio Local Government Expenditure Database and require political subdivision participation, to require the state retirement systems to participate in the Ohio State Government Expenditure Database, and to make an appropriation.

H. B. No. 414 - Representative Swearingen.

To enact section 5534.645 of the Revised Code to designate a portion of State Route 163 in Ottawa County as the "Navy Seaman Jadwisiak Memorial Highway."

H. B. No. 415 - Representatives Brent, Callender.

Cosponsors: Representatives Lampton, Young, White, E., Lett, Somani, Brownlee, Williams, Fischer, Sweeney, Brennan, Synenberg, Grim, Piccolantonio, Lawson-Rowe, Cockley.

To amend sections 3314.03, 3326.11, and 3328.24 and to enact section 3319.48 of the Revised Code to enact the Creating a Respectful and Open World for Natural Hair (CROWN) Act to prohibit discrimination by a public school against an individual based on hair texture and protective hair styles.

Said bills were considered the first time.
