#### INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 177 - Representatives Williams, Tims.

To amend sections 181.25, 2929.06, 2945.79, 2945.80, 2945.81, 2953.21, and 2953.23 and to enact section 2945.811 of the Revised Code to allow a person to file a motion for a new trial or a petition for postconviction relief if the person produces new evidence that would establish a strong probability of a different result at trial.

## H. B. No. 178 - Representatives Troy, Williams.

Cosponsors: Representatives Abdullahi, Brennan, Brent, Brewer, Brownlee, Denson, Grim, Jarrells, Lett, Miller, J., Mohamed, Piccolantonio, Rader, Russo, Sigrist, Sweeney, Synenberg, Upchurch, White, E.

To enact section 5101.546 of the Revised Code to establish a supplemental benefit allotment for certain recipients of supplemental nutrition assistance program benefits and to make an appropriation.

## H. B. No. 179 - Representative Stephens.

To amend section 5703.21 and to enact section 5703.83 of the Revised Code to create a statewide screening system for certain property tax reductions and to make an appropriation.
