## **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 237** - Representatives Somani, Piccolantonio. Cosponsors: Representatives Upchurch, Brennan, Brownlee, Russo, McNally.

To enact sections 2305.2312, 3732.01, 3732.02, 3732.03, 3732.04, 3732.05, 3732.06, 3732.08, 3732.09, 3732.11, 3732.13, and 3732.14 of the Revised Code to protect assisted reproduction care.

H. B. No. 238 - Representatives Rogers, Lorenz.

To amend sections 4521.01 and 4521.08 and to enact section 4521.20 of the Revised Code to establish specified parking requirements.

H. B. No. 239 - Representatives Cockley, Abdullahi.

Cosponsors: Representatives Brennan, Miller, J., Rader, Grim, Hall, D., Upchurch, Synenberg, Brownlee, Sigrist, Somani, Jarrells, Piccolantonio, Lett, Lawson-Rowe, Brent, Sims, Troy, Robinson, Brewer, McNally, White, E.

To enact section 5.266 of the Revised Code to designate the second week of April as National Library Week.

H. B. No. 240 - Representatives Lawson-Rowe, Thomas, C.

To amend sections 955.11, 955.22, 955.222, 955.54, 955.99, and 956.99 and to enact sections 955.13, 955.60, and 956.25 of the Revised Code to make changes to the laws governing dogs and other companion animals and to name this act Avery's Law.

H. B. No. 241 - Representatives Thomas, C., Lawson-Rowe.

To amend section 955.222 and to enact section 955.13 of the Revised Code to require a 10-day quarantine period for a dog following an attack and to require a court, under certain circumstances, to hold a hearing to determine the dog's disposition.

Said bills were considered the first time.
