INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 630 - Representative Dean.

To amend section 4513.34 of the Revised Code regarding police escorts for farm equipment and vehicles that haul agricultural equipment and produce.

H. B. No. 631 - Representatives Ghanbari, Miller, K.

To amend sections 3796.06 and 3796.99 of the Revised Code to modify prohibitions regarding underage possession, consumption, and purchase of marijuana.

H. B. No. 632 - Representative Ritter.

To amend sections 4507.01, 4507.06, 4507.13, 4507.51, and 4507.52 of the Revised Code to allow a driver's license and a state identification card to indicate that the licensee or cardholder is a Gold Star Family member.

H. B. No. 633 - Representatives Grim, Abdullahi.

Cosponsors: Representatives Troy, McNally, Brewer, Sims, Russo.

To enact section 1345.023 of the Revised Code to enact the The Fee Transparency Act prohibiting a supplier from advertising, displaying, or offering a price for a good or service that does not include all mandatory fees and charges.
