To enact section 5534.448 of the Revised Code to designate a portion of United States Route 6 in Lorain County as the "Police Officer Phillip Wagner Memorial Highway."

**H. B. No. 417** - Representatives Plummer, Young.

To amend sections 109.803, 955.54, 955.99, 959.131, 959.99, 2921.321, and 2929.18 and to enact sections 955.55, 955.56, and 955.57 of the Revised Code to prohibit the abuse of a companion animal corpse, to prohibit an animal abuse offender from owning a dog in certain circumstances, and to establish mandatory fines for violations of an animal abuse offense.

**H. B. No. 418** - Representatives Brennan, White, E.

To amend section 5.05 of the Revised Code to correct the latin name of the Buckeye, the state tree.

**H. J. R. No. 6** - Representatives Fischer, Lear.

Cosponsors: Representatives Hall, T., Williams, Demetriou, Workman, Gross.

Proposing to amend Section 2 of Article XII of the Constitution of the State

of Ohio to limit property taxes, whether voted or unvoted, to one and one-quarter per cent or, for certain owner-occupied homes, one per cent of real property's true value.

Said bills and joint resolution were considered the first time.
