Hall of the House of Representatives, Columbus, Ohio Tuesday, September 23, 2025, 9:00 o'clock a.m.

The House met pursuant to adjournment.

Pursuant to House Rule No. 25, the Clerk called the House to order.

Representative McClain was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

#### INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 462 - Representative Richardson.

To amend sections 3313.718 and 3314.141 of the Revised Code regarding student use of a nasal epinephrine delivery device.

H. B. No. 463 - Representatives Klopfenstein, Lorenz.

Cosponsors: Representatives Williams, Gross, Miller, K., Claggett, Willis.

To amend sections 4507.05, 4507.071, 4507.21, and 4508.02 and to enact section 4508.041 of the Revised Code to make changes to driver education requirements.

H. B. No. 464 - Representative Richardson.

To amend section 5104.02 of the Revised Code to exempt from licensure family child care providers certified by a branch of the United States armed forces

### H. B. No. 465 - Representative Upchurch.

Cosponsors: Representatives Mohamed, Williams, Brennan, Fischer.

To amend sections 4303.271, 5743.15, and 5743.61 of the Revised Code to require the renewal of various licenses or permits related to liquor, tobacco, and vapor products within forty-eight hours of filing.

#### H. B. No. 466 - Representatives Lear, Ritter.

Cosponsors: Representatives Thomas, D., Hall, T., Dean, Fischer, Johnson, Workman, Gross.

To amend sections 511.27, 511.28, 1545.041, 1545.21, 3709.29, 5705.23, and 5705.34 and to enact sections 511.271, 1545.212, and 5705.171 of the Revised Code to require certain subdivisions to obtain the approval of the body that created the subdivision before levying a property tax.

## H. B. No. 467 - Representatives McNally, Rader.

Cosponsors: Representatives Brennan, Lett, Grim, Russo, Brownlee.

To enact sections 4933.51, 4933.52, 4933.53, 4933.55, 4933.57, 4933.58, 4933.59, and 4933.60 of the Revised Code to prohibit certain public utilities from recovering political expenditure costs from their customers.

#### H. B. No. 468 - Representatives McNally, Rader.

Cosponsors: Representatives Brennan, Lett, Upchurch.

To amend section 4511.01 of the Revised Code to designate certain OEPA and PUCO vehicles as public safety vehicles that are exempt from certain traffic laws and to make an appropriation.

#### H. B. No. 469 - Representative Claggett.

To enact sections 1357.01, 1357.02, 1357.03, 1357.04, 1357.05, 1357.06, 1357.07, 1357.08, 1357.09, 1357.10, 1357.11, and 1357.12 of the Revised Code to declare artificial intelligence systems nonsentient and to prohibit them from obtaining legal personhood.

#### H. B. No. 470 - Representative Upchurch.

Cosponsors: Representatives Brownlee, Mohamed, Lett, McNally, Brennan, Brent, Grim, Russo.

To amend sections 3501.05, 3503.09, 3503.12, 3503.13, 3503.16, 3503.19, 3503.21, 3503.28, 3503.30, 3503.33, 3505.181, 3505.183, 3599.11, 3599.18, 4506.07, 4507.06, and 4507.51; to enact new section 3503.11; and to repeal section 3503.11 of the Revised Code to create an automatic voter registration system.

#### H. B. No. 471 - Representative Abrams.

To enact section 5534.971 of the Revised Code to designate a portion of Interstate 275 in Hamilton County as the "Deputy Larry Henderson Memorial Highway."

Said bills were considered the first time.
