INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 419 - Representatives Salvo, Kishman.

Cosponsors: Representatives Gross, Richardson, Odioso, Synenberg, Brennan, Robb Blasdel, Stephens.

To amend section 4501.21 and to enact section 4503.727 of the Revised Code to create the "Save22" license plate.

H. B. No. 420 - Representatives Click, Willis.

Cosponsors: Representatives Thomas, D., Newman, Hall, T., Gross, Hiner, Deeter.

To amend sections 505.37, 505.48, 505.481, 3311.21, 3311.50, 3318.05, 3318.052, 3318.08, 3318.18, 3318.44, 3354.12, 3358.11, 5705.03, 5705.19, 5705.191, 5705.192, 5705.198, 5705.199, 5705.21, 5705.212, 5705.213, 5705.215, 5705.217, 5705.218, 5705.219, 5705.2111, 5705.2114, 5705.222, 5705.23, 5705.233, 5705.25, 5705.251, 5748.02, 5748.03, 5748.04, and 5748.09; to enact section 5705.171; and to repeal section 5705.261 of the Revised Code to disallow and, by 2030, eliminate property taxes levied for a continuing period of time and to name this act The Taxpayers Freedom Trilogy – Act One: Discontinuing the Continuum.

H. B. No. 421 - Representatives Click, Thomas, D.

To enact sections 5705.262 and 5705.263 of the Revised Code to allow electors to reduce unvoted property taxes by initiative and to name this act the Taxpayers Freedom Trilogy – Act Two: Arresting Inside Millage.

H. B. No. 422 - Representatives Click, Newman.

Cosponsors: Representatives Willis, Gross, Deeter.

To amend sections 345.02, 511.07, 757.02, and 3318.06 and to enact section 5705.171 of the Revised Code to increase the approval threshold

required for passage of certain property taxes and to name this act the Taxpayers Freedom Trilogy – Act Three: The Triumph of the Taxpayer.

H. B. No. 423 - Representative Deeter.

To amend sections 109.572, 4731.051, 4731.07, 4731.071, 4731.224, 4731.2210, 4731.24, 4731.25, 4731.251, 4776.01, and 4776.20 and to enact sections 3702.3013, 3727.26, 4787.01, 4787.02, 4787.03, 4787.04, 4787.05, 4787.06, 4787.07, 4787.08, 4787.09, 4787.10, 4787.11, 4787.12, 4787.13, 4787.14, 4787.15, 4787.16, 4787.17, 4787.18, 4787.19, 4787.20, 4787.21, 4787.22, and 4787.99 of the Revised Code to regulate the practice of surgical assistants and surgical technologists.

H. B. No. 424 - Representatives Willis, Craig.

To amend section 145.295 of the Revised Code regarding transfers or purchases of certain retirement service credit.
