5571.01, 5736.02, 5736.04, and 5736.13; to enact sections 1548.062, 4503.183, 4503.261, 4503.262, 4505.072, 4511.15, 4511.765, 4561.03, 4955.52, 4955.53, 4955.55, 4955.57, 4981.36, 4981.361, 5501.041, 5511.11, 5515.10, 5517.06, and 5517.08; and to repeal sections 4506.072, 4507.021, 4507.063, 4507.511, 4511.351, 4511.491, and 5501.60 of the Revised Code and to amend Section 755.20 of H.B. 23 of the 135th General Assembly to make appropriations for programs related to transportation for the biennium beginning July 1, 2025, and ending June 30, 2027, and to provide authorization and conditions for the operation of those programs, was taken up for consideration the third time.

The question being, "Shall the bill pass?"
