The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Stewart was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 19 - Representatives Bird, Williams.

Cosponsors: Representatives Brennan, Fowler Arthur, Hall, T., John, Johnson, King, Ray, Stewart, Thomas, C.

To amend section 4301.69 of the Revised Code to reduce the mental state, from knowingly to recklessly, that applies to the prohibition against allowing an underage person to possess or consume alcohol in a private or public place.

H. B. No. 20 - Representatives Hall, T., Plummer.

To amend section 2903.22 and to enact section 2927.31 of the Revised Code to prohibit a person from knowingly harassing or impeding an emergency service responder who is engaged in the lawful performance of a legal duty and to clarify that heightened penalties apply for menacing a probation officer.

H. B. No. 21 - Representative King.

Cosponsors: Representatives Barhorst, Creech, John, Williams, Klopfenstein, Gross, Lear, Lorenz.

To amend sections 1716.01 and 5747.01 and to enact sections 1716.22 and 3333.96 of the Revised Code to enact the Health Care Sharing Ministries Freedom to Share Act.

H. B. No. 22 - Representatives Lorenz, Thomas, D.

Cosponsors: Representatives Fischer, Williams, White, A., Deeter, Willis, Sweeney, Schmidt, Sigrist, John, Thomas, C., Hiner, Brennan, Klopfenstein, Teska.

To amend sections 323.151, 323.152, 323.153, 4503.064, 4503.065, and 4503.066 of the Revised Code to authorize a full homestead exemption for surviving spouses of members of the uniformed services killed in the line of duty.

H. B. No. 23 - Representatives Roemer, Williams.

Cosponsors: Representatives Robb Blasdel, Brennan, Click, Daniels, Deeter, Gross, John, Johnson, Klopfenstein, Richardson, Schmidt, Sigrist, Thomas, C., Young.

To enact section 5502.54 of the Revised Code to create the escaped convict alert program.

H. B. No. 24 - Representatives Callender, Sweeney.

Cosponsors: Representatives Williams, Rader, Russo, Synenberg, Piccolantonio, Brennan, Troy, Sigrist, Brewer, Grim, Lett, Baker, Cockley, Hall, D.

To amend sections 3923.33, 3923.331, 3923.332, 3923.337, 3923.338, 3923.339, and 3923.42 and to enact section 3923.3310 of the Revised Code to provide Medigap policies for Medicare-eligible individuals under the age of 65.

H. B. No. 25 - Representatives Jarrells, Ray.

To enact sections 3301.96 and 3333.89 of the Revised Code to establish the Foster-to-College Scholarship Program, to require the Department of Education and Workforce to hire a full-time school foster care liaison, and to make an appropriation for the Foster-to-College Scholarship Program.
