**"Section 3. FOOD BANK FUNDING DURING FEDERAL GOVERNMENT SHUTDOWN**

On the effective date of this section, or as soon as possible thereafter, the Director of Job and Family Services shall certify to the Director of Budget Management the funding necessary to meet increased food bank needs during the federal government shutdown. The Director of Job and Family Services shall coordinate with the Ohio Association of Food Banks to

determine the amount necessary. The amount certified, up to \$100,000,000 in total, is hereby appropriated. The funds shall come from the Controlling Board Emergency Purposes/Contingencies Fund (Fund 5KM0), or in the event that this fund does not have a sufficient cash balance, the Budget Stabilization Fund (Fund 7013).

The Director of Job and Family Services shall coordinate with the Ohio Association of Food Banks to distribute funds as needed. The Ohio Association of Food Banks shall coordinate with Meals on Wheels and other local, non-profit food delivery groups to distribute food to seniors, individuals with a disability, and others who lack transportation to food banks and food pantries. Funds shall remain available until the federal government shutdown ends or Supplemental Nutrition Assistance Program (SNAP) benefits resume, whichever occurs first.

**Section 4.** Within the limits set forth in this act, the Director of Budget and Management shall establish accounts indicating the source and amount of funds for each appropriation made in this act, and shall determine the manner in which appropriation accounts shall be maintained. Expenditures from operating appropriations contained in this act shall be accounted for as though made in, and are subject to all applicable provisions of, H.B. 96 of the 136th General Assembly."
