**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 648** - Representatives Kishman, Miller, M.

Cosponsors: Representatives Salvo, Brennan.

To amend sections 1315.05 and 1315.18 and to enact sections 1349.57, 1349.571, 1349.572, 1349.573, 1349.574, 1349.575, 1349.576, 1349.577, 1349.578, 1349.579, 1349.5710, 1349.5711, and 1349.5712 of the Revised Code to establish regulations for digital asset kiosks and require they be registered as money transmitters.

**H. B. No. 649** - Representatives Williams, Swearingen.

To amend sections 5104.015 and 5104.04 and to enact sections 5104.044, 5104.303, 5104.304, and 5104.361 of the Revised Code to require video surveillance of child care centers, to establish an online portal for tracking child care center attendance, to require investigations of waste, fraud, and abuse allegations relating to providers of publicly funded child care, and to name this act the Child Care Fraud Prevention Act.

**H. B. No. 650** - Representative Workman.

Cosponsors: Representatives Holmes, Willis, Claggett, King, Brennan, Daniels.

To establish the Frontier Technologies and Quantum Computing Commission.

**H. B. No. 651** - Representative Johnson.

To enact section 5534.619 of the Revised Code to designate the bridge spanning the Scioto River on State Route 207 as the "Sgt. Andrew Lansing Memorial Bridge."

**H. B. No. 652** - Representatives Lorenz, Brennan.  
Cosponsors: Representatives King, Young, McNally, Synenberg, Click, Cockley, Pizzulli, Sigrist, Rogers, Barhorst, Hall, T., Stephens, Glassburn, Jarrells.

To amend section 3937.26 and to enact section 3937.261 of the Revised Code regarding time frames for insurance policy nonrenewal notifications.

Said bills were considered the first time.
