**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 653** - Representative Brewer.

To amend section 4521.02 of the Revised Code to establish maximum late fees for civil parking tickets.

**H. B. No. 654** - Representatives Deeter, Manning.

To amend section 2927.01 of the Revised Code to enact Amanda Dean's Law to increase the penalties for abuse of a corpse.

**H. B. No. 655** - Representative Williams.

Cosponsor: Representative Johnson.

To amend section 2919.24 of the Revised Code to create the offense of neglect of parental duties.

**H. B. No. 656** - Representative Williams.

Cosponsors: Representatives Hall, T., Robb Blasdel.

To amend sections 2903.14 and 2927.15 of the Revised Code to create the offense of negligent assault of a peace officer.

**H. B. No. 657** - Representatives Troy, Sigrist.

Cosponsors: Representatives Baker, Brennan, Brewer, Piccolantonio, Brownlee, Bryant Bailey, Glassburn, Miller, J., McNally, Rader, Russo, Synenberg.

To amend sections 4901.02 and 4901.021 and to enact section 4901.022 of the Revised Code to make various changes to the Public Utilities Commission nominating council and nomination process.

**H. B. No. 658** - Representatives Cockley, Salvo.

To enact section 4503.728 of the Revised Code to create the "SHELTER" license plate.

**H. B. No. 659** - Representatives Russo, Synenberg.

To amend sections 2305.111 and 2315.18 of the Revised Code regarding childhood sexual abuse and student sexual abuse and to amend the version of section 2305.111 that is scheduled to take effect on October 12, 2028, to continue the change on and after that date.

**H. B. No. 660** - Representative Russo.

Cosponsors: Representatives Piccolantonio, Brennan, Sigrist, McNally, Upchurch.

To amend section 5919.34 of the Revised Code regarding the Ohio National Guard Scholarship Program.

Said bills were considered the first time.
