**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 661** - Representatives Bird, Odioso.

Cosponsors: Representatives Holmes, Ritter, Pizzulli, Miller, K., Peterson, Creech, Mathews, A., Abrams, Stewart, Salvo, Click, Manning, Hoops.

To enact sections 3373.01, 3373.02, and 3373.03 of the Revised Code to prohibit a middle or high school athlete from earning compensation from the athlete's name, image, or likeness.

**H. B. No. 662** - Representatives Fischer, Newman.

To amend section 2917.12 of the Revised Code to increase the penalty for disturbing a lawful meeting under certain circumstances.

**H. B. No. 663** - Representatives Cockley, Fischer.

To create the Artificial Intelligence Study Commission to study and make recommendations regarding the use of artificial intelligence in state and local government.

**H. B. No. 664** - Representatives Fischer, Deeter.

To amend section 4741.19 of the Revised Code to establish procedures that allow a registered veterinary technician to establish a veterinarian-client-patient relationship on behalf of a veterinarian to administer vaccines and antiparasitic medication to a dog or cat.

**H. B. No. 665** - Representatives Cockley, Fischer.

Cosponsors: Representatives Rogers, Brennan, Lett, Soman, Rader, Tims, Bryant Bailey, Jarrells, Abdullahi, Hall, D.

To amend sections 1331.01, 1331.04, and 1331.16 and to enact sections 1331.05 and 1331.50 of the Revised Code to regulate the use of pricing algorithms.

**H. B. No. 666** - Representative Mathews, T.

To enact section 3333.56 of the Revised Code to establish the Ohio Tech Institute.

**H. B. No. 667** - Representative Abrams.

Cosponsors: Representatives Johnson, Robb Blasdel, Hall, T., John, White, A., Ray, Miller, K., Bird, Schmidt, Sigrist, Ghanbari.

To amend sections 2929.141, 2929.34, 2935.10, 2935.11, 5120.021, 5120.038, 5589.21, and 5589.211 of the Revised Code to enact the Reagan Tokes and Patrick Heringer Act to require certain warrants to be entered into LEADS, to require GPS monitoring of offenders released from prison, and to modify T-CAP requirements.

Said bills were considered the first time.
