FIRST DAY Senate Chamber, Columbus, Ohio Monday, January 6, 2025, 1:30 p.m.

This being the day fixed by law for the meeting of the General Assembly in regular session, the senators and senators-elect of the One Hundred Thirty-Sixth General Assembly of the State of Ohio, met in the Senate Chamber and were called to order by Senator Matt Huffman, President of the One Hundred Thirty-Sixth General Assembly.

Prayer was offered by Pastor Peter Marcis, St. Paul Lutheran Church, Napoleon, Ohio. The colors were presented by the Ohio State Highway Patrol Color Guard.

The children and grandchildren of the senators and senators-elect assembled in the well and led the Chamber in the Pledge of Allegiance following the presentation of the colors.

The National Anthem was performed by Gina Campbell.

The President directed the Clerk to call the Senatorial Districts in their numerical order when the following named persons presented their certificates of election as Senators from their respective districts to the One Hundred Thirty-Sixth General Assembly, and the following named persons who were previously elected in 2022:

The election of the President being the first order, the Chair appointed Senator Wilson to preside during the election of the President.
