# INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 278 - Senator Johnson.

To amend section 9.68 of the Revised Code to permit individuals to seek punitive or exemplary damages against municipal corporations that pass gun control measures.

S. B. No. 279 - Senator Johnson.

To amend sections 2923.121 and 2923.1214 and to enact section 2923.1215 of the Revised Code to prohibit a business, state agency, or political subdivision from discouraging or prohibiting a law enforcement officer from carrying a weapon while off duty.

S. B. No. 280 - Senator Johnson.

Cosponsor: Senator O'Brien.

To amend sections 4501.01 and 4503.181 of the Revised Code to allow for the registration of a high-mobility multipurpose wheeled vehicle manufactured for military purposes, otherwise known as a humvee, as a historical motor vehicle.

# S. B. No. 281 - Senator Roegner.

To amend section 306.04 of the Revised Code to authorize a board of county commissioners, on its own behalf, to award a franchise for the operation of a public transit system.
