WHEREAS, The Governor has nominated James Tressel to fill this vacancy in the office of Lieutenant Governor; now therefore be it

RESOLVED, That the Senate and the House of Representatives hereby confirm the nomination of James Tressel by the adoption of this resolution by a majority vote of the members elected to each house in accordance with Section 17a of Article III of the Constitution of the State of Ohio; and be it further

RESOLVED, That the Clerk of the Senate and the Clerk of the House of Representatives shall spread upon the pages of the Journal of each house this resolution and the vote of the members of that house voting on confirmation of that nomination.

Each state institution of higher education, as defined in section 3345.011 of the Revised Code, shall adopt a policy that establishes a system of faculty evaluations to be conducted on an annual basis for each full-time faculty member, including tenured faculty, who it directly compensates. The evaluation shall be comprehensive and include standardized, objective, and measurable performance metrics regarding teaching, research, service, and other categories as determined by the state institution of higher education."
