INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 106 - Senator Reineke.

To enact sections 4933.51, 4933.53, 4933.54, 4933.55, 4933.57, and 4933.59 of the Revised Code to regulate the ownership of electric vehicle charging stations.

S. B. No. 107 - Senator Brenner.

Cosponsors: Senators Cirino, Lang, Wilkin, O'Brien.

To amend sections 3501.01, 3505.03, 3505.04, 3513.254, 3513.255, 3513.256, and 3513.259 of the Revised Code to require state and school district board members to appear on the ballot with a party designation.

S. B. No. 108 - Senator Brenner.

To amend section 4905.02 and to enact sections 4933.51, 4933.52, 4933.54, 4933.56, 4933.57, 4933.59, 4933.60, and 4933.63 of the Revised Code to

exempt from regulation as a public utility certain persons or entities providing behind-the-meter utility services and to allow the Public Utilities Commission to register providers of such services.

S. B. No. 109 - Senators Blessing, Smith.

To amend sections 3301.91 and 3313.819 of the Revised Code to provide breakfast and lunch at no cost to public and chartered nonpublic school students, and to make an appropriation.

S. B. No. 110 - Senators Cirino, Chavez.

To amend sections 122.15, 122.151, 122.152, 122.153, 122.154, 122.155, 5725.98, and 5729.98 of the Revised Code to modify the availability of and eligibility for tax credits awarded under the rural business growth program.
