RESOLUTIONS REPORTED BY COMMITTEE

S. C. R. No. 5-Senator Koehler.

Cosponsors: Senators Schaffer, Lang, Brenner, Huffman, Wilson, Johnson, Romanchuk.

To urge the President of the United States to support the Ohio Department of Medicaid's request to implement work requirements for certain Medicaid recipients.

WHEREAS, H.B. 49 of the 132nd General Assembly required the Medicaid Director to seek approval from the United States Centers for Medicare and Medicaid Services (CMS) to impose work requirements for

certain Medicaid recipients; and

WHEREAS, The Ohio Department of Medicaid and Medicaid Director submitted to CMS in April 2018 a "Group VIII Work Requirement and Community Engagement 1115 Demonstration Waiver Application" to authorize the state to require all new adult expansion group beneficiaries, ages 19 through 49, with certain exemptions, to participate in and timely report 80 hours per month of qualifying community engagement activities, such as employment, education, or job skills training, as a condition of continued Medicaid eligibility; and

WHEREAS, CMS approved the request in March 2019, but before the Section 1115 demonstration waiver could be implemented, CMS withdrew its approval in August 2021; and

WHEREAS, H.B 33 of the 135th General Assembly requires the Medicaid Director, between February 1, 2025, and March 1, 2025, to apply to CMS for a new approval to implement work requirements for the Medicaid expansion eligibility group; and

WHEREAS, The Department of Medicaid and Medicaid Director recently published a Public Notice and Request for Comment on a "Group VIII 1115 Demonstration Waiver Application" intended for submission to CMS in February 2025; and

WHEREAS, Governor Mike DeWine has stated that implementing Medicaid work requirements is consistent with the state's goal to empower all people to reach their full potential and its responsibility to ensure that as many Ohioans as possible are on a pathway to financial independence; and

WHEREAS, According to the Department of Medicaid, in addition to promoting economic stability and financial independence, implementing Medicaid work requirements will improve health outcomes by encouraging individuals to be engaged with their health and health care; and

WHEREAS, Adding work requirements to the Medicaid program would ensure that Medicaid recipients continue to maintain existing employable skills or develop and improve employable skills; now therefore be it

RESOLVED, That we, the members of the 136th General Assembly of the State of Ohio, urge the President of the United States to support the Department of Medicaid's request to impose work requirements for certain Medicaid recipients; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this resolution to the President of the United States, the Administrator of CMS, the members of the Ohio Congressional delegation, and the news media of Ohio.

S. R. No. 21-Senator Schaffer.

Cosponsors: Senators Brenner, Koehler, Liston, DeMora, O'Brien, Wilkin, Weinstein, Smith, Patton, Johnson, Craig.

To urge the U.S. Congress to support the provision of prompt and comprehensive mental health treatment to military personnel and veterans who are suffering from post-traumatic stress disorder and other service-related stress disorders

WHEREAS, According to the National Institutes of Health, the most common mental health problems faced by returning troops are, in order, depression, post-traumatic stress disorder (PTSD), substance use disorder, anxiety disorder, and serious mental illness such as schizophrenia or bipolar disorder; and

WHEREAS, The wars in Afghanistan and Iraq were the longest combat operations since Vietnam, and the stress of being in a war zone or long-term naval deployment combined with the stress of being away from home for long periods of time can increase the chance of having PTSD or other mental health problems; and

WHEREAS, According to research conducted at Brown University's Watson Institute for International and Public Affairs, 30,177 active duty personnel and veterans who served in the military after the September 11, 2001, terrorist attacks have died by suicide compared to the 7,057 service

members killed in combat in those same 20 years; and

WHEREAS, According to the United Service Organizations, Inc., suicide rates among active-duty military members in 2021 were at an all-time high since recordkeeping began after September 11, 2001, and had been increasing over the previous five years at an alarmingly steady pace; and

WHEREAS, The U.S. Department of Veterans Affairs, the U.S. Department of Defense, and many other entities are working to identify and address the issues of veterans and military personnel suffering from PTSD and other service-related stress disorders; and

WHEREAS, The United States Department of Veterans Affairs has established the National Center for PTSD as a center of excellence for research and education on the prevention, understanding, and treatment of PTSD; and

WHEREAS, According to the U.S. Department of Veterans Affairs, each medical center within the Department has PTSD specialists who provide treatment for veterans with PTSD; and

WHEREAS, Mental trauma may not be as easily identifiable as the physical trauma suffered by military personnel and veterans, and may require additional resources to identify and treat; and

WHEREAS, Only qualified and licensed medical professionals with experience treating military personnel and veterans should have the authority to approve or disapprove mental health treatment of military personnel and veterans experiencing service-related stress disorders; and

WHEREAS, While support and treatment programs are available to veterans and military personnel suffering from PTSD or other service-related stress disorders, there are many service members who are still not receiving sufficient treatment; and

WHEREAS, Several recommendations made by the U.S. Government Accountability Office to the U.S. Department of Defense have not yet been fully implemented to ensure that PTSD and traumatic brain injuries are appropriately considered prior to separating certain service members from the military for misconduct, thereby placing both the earned benefits due to veterans and the mental health of some service members and veterans in jeopardy; and

WHEREAS, The service members who willingly sacrifice their safety for the freedom of all Americans deserve to have access to all the resources and support services necessary for them to reintegrate into society; and

WHEREAS, According to the U.S. Department of Veterans Affairs, a person who served in the active military, naval, or air service and who was discharged or released under conditions other than dishonorable may qualify for VA health care benefits including qualifying Reserve and National Guard

members; now therefore be it

RESOLVED, That we, the members of the Ohio Senate of the 136th General Assembly, urge the United States Congress to support the provision of prompt and comprehensive mental health diagnosis and treatment to all military personnel and veterans who are suffering from PTSD and other service-related stress disorders; and be it further

RESOLVED, That we urge the Secretary of Veterans Affairs to ensure that each of the U.S. Government Accountability Office's recommendations is implemented to guarantee that PTSD and traumatic brain injuries are appropriately considered prior to separating certain service members from the military for misconduct; and be it further

RESOLVED, That we believe military personnel and veterans who had separation or discharge from military service related to mental health issues should have consideration to correct records to a more honorable discharge; and be it further

RESOLVED, That we affirm that post-military service civilian income should not have any bearing on eligibility for healthcare-related benefits or treatment; and be it further

RESOLVED, That the Clerk of the Senate transmit duly authenticated copies of this resolution to the President of the United States, the Secretary of Veterans Affairs, the Speaker and Clerk of the U.S. House of Representatives, the President Pro Tempore and Secretary of the U.S. Senate, the members of the Ohio Congressional delegation, and the news media of Ohio.

The question being, "Shall the resolution, **S. R. No. 21**, be adopted? Senator Weinstein moved to amend as follows:

After line 21, insert:

"WHEREAS, According to the U.S. Department of Veterans Affairs, in 2022 nationally an average of 17.6 veterans committed suicide per day, and in that year 232 Ohio veterans committed suicide, a rate that was nearly double the percentage of suicides committed by other Ohioans; and"

After line 87, insert:

"RESOLVED, That we believe it is crucial to preventing suicides among veterans that the Department of Veterans Affairs must commit to maintaining full staffing by halting the elimination of mental health providers and staff, including the Veterans Crisis Line, and reinstate those that have been fired; and be it further"
