# SEVENTY-THIRD DAY Senate Chamber, Columbus, Ohio **Tuesday, September 30, 2025, 1:30 p.m.**

### INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 274 - Senators Cirino, Brenner.

To amend sections 2151.461, 3129.03, 3313.473, 3798.07, and 3798.12 and to repeal section 5122.04 of the Revised Code to prohibit the provision of mental health services to minors without parental consent.

S. B. No. 275 - Senators Craig, Reynolds.

To amend sections 319.202, 319.302, 323.155, 323.158, 4503.0610, and 5323.02 and to enact sections 323.21 and 323.22 of the Revised Code to allow eligible homeowners to defer the payment of a portion of their property taxes.

S. B. No. 276 - Senator Roegner.

To enact section 4732.42 of the Revised Code to ratify the Interstate Compact for School Psychologists.

S. B. No. 277 - Senator Gavarone

To enact section 2151.032 of the Revised Code to clarify that a child who is granted permission to engage in independent activities is not considered to be an abused or neglected child.
