Specifies that the criteria for prohibiting a retroactive denial of a prior authorization related to the health care service, drug, or device meeting the health plan issuer's standards for medical necessity and prior authorization only applies to health benefit plans delivered, issued for delivery, or renewed before January 1, 2028, as opposed to health benefit plans issued before the first day of January following the effective date of the bill.	44 45 46 47 48 49 50 51
