To amend sections 4501.21 and 4503.733 and to enact	1
section 5534.90 of the Revised Code to designate	2
the bridge spanning the Grand River in Lake	3
County as the "Specialist Jacob A. Ashton	4
Memorial Bridge" and to make changes to the	5
"Juvenile Diabetes Research Foundation" license	6
plate.	7

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 4501.21 and 4503.733 be amended	8
and section 5534.90 of the Revised Code be enacted to read as	9
follows:	10

Sec. 4501.21. (A) There is hereby created in the state	11
treasury the license plate contribution fund. The fund shall	12
consist of all contributions for specialty license plates paid	13
by motor vehicle registrants and collected by the registrar of	14
motor vehicles pursuant to the Revised Code sections referenced	15

in division (B) of this section. 16

(B) The registrar shall pay the contributions the 17
registrar collects in the fund as follows: 18

The registrar shall pay the contributions received 19
pursuant to section 4503.491 of the Revised Code to the breast 20
cancer fund of Ohio, which shall use that money only to pay for 21
programs that provide assistance and education to Ohio breast 22
cancer patients and that improve access for such patients to 23
quality health care and clinical trials and shall not use any of 24
the money for abortion information, counseling, services, or 25
other abortion-related activities. 26

The registrar shall pay the contributions the registrar 27
receives pursuant to section 4503.492 of the Revised Code to the 28
organization cancer support community central Ohio, which shall 29
deposit the money into the Sheryl L. Kraner Fund of that 30
organization. Cancer support community central Ohio shall expend 31
the money it receives pursuant to this division only in the same 32
manner and for the same purposes as that organization expends 33
other money in that fund. 34

The registrar shall pay the contributions received 35
pursuant to section 4503.493 of the Revised Code to the autism 36
society of Ohio, which shall use the contributions for programs 37
and autism awareness efforts throughout the state. 38

The registrar shall pay the contributions the registrar 39
receives pursuant to section 4503.494 of the Revised Code to the 40
national multiple sclerosis society for distribution in equal 41
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 42
chapters of the national multiple sclerosis society. These 43
chapters shall use the money they receive under this section to 44

assist in paying the expenses they incur in providing services 45
directly to their clients. 46

The registrar shall pay the contributions the registrar 47
receives pursuant to section 4503.495 of the Revised Code to the 48
national pancreatic cancer foundation, which shall use the money 49
it receives under this section to assist those who have 50
pancreatic cancer and their families. 51

The registrar shall pay the contributions the registrar 52
receives pursuant to section 4503.496 of the Revised Code to the 53
Ohio sickle cell and health association, which shall use the 54
contributions to help support educational, clinical, and social 55
support services for adults who have sickle cell disease. 56

The registrar shall pay the contributions the registrar 57
receives pursuant to section 4503.497 of the Revised Code to the 58
St. Baldrick's foundation, which shall use the contributions for 59
its research and other programs. 60

The registrar shall pay the contributions the registrar 61
receives pursuant to section 4503.498 of the Revised Code to 62
special olympics Ohio, inc., which shall use the contributions 63
for its programs, charitable efforts, and other activities. 64

The registrar shall pay the contributions the registrar 65
receives pursuant to section 4503.499 of the Revised Code to the 66
children's glioma cancer foundation, which shall use the 67
contributions for its research and other programs. 68

The registrar shall pay the contributions the registrar 69
receives pursuant to section 4503.4910 of the Revised Code to 70
the KylerStrong foundation, which shall use the contributions to 71
raise awareness of brain cancer caused by diffuse intrinsic 72
pontine glioma and to fund research for the cure of such cancer. 73

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4911 of the Revised Code to the research institution for childhood cancer at nationwide children's hospital, which shall use the contributions to fund research for the cure of childhood cancers.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4912 of the Revised Code to the Ben Morrison memorial fund, which shall use the contributions for scholarships and other programs that support mental health.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.50 of the Revised Code to the future farmers of America foundation, which shall deposit the contributions into its general account to be used for educational and scholarship purposes of the future farmers of America foundation.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.501 of the Revised Code to the 4-H youth development program of the Ohio state university extension program, which shall use those contributions to pay the expenses it incurs in conducting its educational activities.

The registrar shall pay the contributions received pursuant to section 4503.502 of the Revised Code to the Ohio cattlemen's foundation, which shall use those contributions for scholarships and other educational activities.

The registrar shall pay the contributions received pursuant to section 4503.505 of the Revised Code to the organization Ohio region phi theta kappa, which shall use those contributions for scholarships for students who are members of

that organization. 103

The registrar shall pay the contributions the registrar 104
receives pursuant to section 4503.506 of the Revised Code to 105
Ohio demolay, which shall use the contributions for 106
scholarships, educational programs, and any other programs or 107
events the organization holds or sponsors in this state. 108

The registrar shall pay the contributions received 109
pursuant to section 4503.507 of the Revised Code to the Ohio 110
aerospace institute, which shall use those contributions to 111
facilitate student internships in aerospace and educational 112
programming. 113

The registrar shall pay the contributions received 114
pursuant to section 4503.508 of the Revised Code to the 115
organization bottoms up diaper drive to provide funding for that 116
organization for collecting and delivering diapers to parents in 117
need. 118

The registrar shall pay the contributions the registrar 119
receives pursuant to section 4503.509 of the Revised Code to a 120
kid again, incorporated for distribution in equal amounts to the 121
Ohio chapters of a kid again. 122

The registrar shall pay each contribution the registrar 123
receives pursuant to section 4503.51 of the Revised Code to the 124
university or college whose name or marking or design appears on 125
collegiate license plates that are issued to a person under that 126
section. A university or college that receives contributions 127
from the fund shall deposit the contributions into its general 128
scholarship fund. 129

The registrar shall pay each contribution the registrar 130
receives pursuant to section 4503.512 of the Revised Code to the 131

Iota Phi Theta Fraternity, Incorporated Delta Theta Omega 132
chapter in Ohio. The Iota Phi Theta Fraternity, Incorporated 133
Delta Theta Omega chapter shall use the contributions for the 134
development and perpetuation of scholarship, leadership, 135
citizenship, fidelity, and brotherhood among men and youth in 136
this state. 137

The registrar shall pay the contributions the registrar 138
receives pursuant to section 4503.514 of the Revised Code to the 139
university of Notre Dame in South Bend, Indiana, for purposes of 140
awarding grants or scholarships to residents of Ohio who attend 141
the university. The university shall not use any of the funds it 142
receives for purposes of administering the scholarship program. 143
The registrar shall enter into appropriate agreements with the 144
university of Notre Dame to effectuate the distribution of such 145
funds as provided in this section. 146

The registrar shall pay the contributions the registrar 147
receives pursuant to section 4503.516 of the Revised Code to 148
Marshall university in Huntington, West Virginia, for purposes 149
of awarding grants or scholarships to residents of Ohio who 150
attend the university. The university shall not use any of the 151
funds it receives for purposes of administering the scholarship 152
program. The registrar shall enter into appropriate agreements 153
with Marshall university to effectuate the distribution of such 154
funds as provided in this section. 155

The registrar shall pay the contributions the registrar 156
receives pursuant to section 4503.517 of the Revised Code to the 157
university of Alabama in Tuscaloosa, Alabama, for purposes of 158
awarding grants or scholarships to residents of Ohio who attend 159
the university. The university shall not use any of the funds it 160
receives for purposes of administering the scholarship program. 161

The registrar shall enter into appropriate agreements with the 162
university of Alabama to effectuate the distribution of such 163
funds as provided in this section. 164

The registrar shall pay the contributions the registrar 165
receives pursuant to section 4503.518 of the Revised Code to the 166
Nationwide children's hospital, which shall use the 167
contributions for the "On Our Sleeves" campaign. 168

The registrar shall pay the contributions the registrar 169
receives pursuant to section 4503.519 of the Revised Code 170
equally to NAMI Ohio (national alliance on mental illness of 171
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 172
advocates for addiction recovery). 173

The registrar shall pay the contributions the registrar 174
receives pursuant to section 4503.520 of the Revised Code to 175
Purdue university in West Lafayette, Indiana, for purposes of 176
awarding grants or scholarships to residents of Ohio who attend 177
the university. The university shall not use any of the funds it 178
receives for purposes of administering the scholarship program. 179
The registrar shall enter into appropriate agreements with 180
Purdue university to effectuate the distribution of such funds 181
as provided in this section. 182

The registrar shall pay the contributions the registrar 183
receives pursuant to section 4503.521 of the Revised Code to the 184
Ohio bicycle federation to assist that organization in paying 185
for the educational programs it sponsors in support of Ohio 186
cyclists of all ages. 187

The registrar shall pay the contributions the registrar 188
receives pursuant to section 4503.522 of the Revised Code to the 189
"friends of Perry's victory and international peace memorial, 190

incorporated," a nonprofit corporation organized under the laws 191
of this state, to assist that organization in paying the 192
expenses it incurs in sponsoring or holding charitable, 193
educational, and cultural events at the monument. 194

The registrar shall pay the contributions the registrar 195
receives pursuant to section 4503.523 of the Revised Code to the 196
fairport lights foundation, which shall use the money to pay for 197
the restoration, maintenance, and preservation of the 198
lighthouses of fairport harbor. 199

The registrar shall pay the contributions the registrar 200
receives pursuant to section 4503.524 of the Revised Code to the 201
Massillon tiger football booster club, which shall use the 202
contributions only to promote and support the football team of 203
Washington high school of the Massillon city school district. 204

The registrar shall pay the contributions the registrar 205
receives pursuant to section 4503.525 of the Revised Code to the 206
United States power squadron district seven which shall annually 207
distribute the contributions in equal amounts to all United 208
States power squadrons located in the state. Each power squadron 209
district shall use the money it receives under this section to 210
pay for the educational boating programs each district holds or 211
sponsors within this state. 212

The registrar shall pay the contributions the registrar 213
receives pursuant to section 4503.526 of the Revised Code to the 214
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 215
international, which shall use the money it receives under this 216
section to pay the costs of its educational and humanitarian 217
activities. 218

The registrar shall pay the contributions the registrar 219

receives pursuant to section 4503.528 of the Revised Code to the 220
Ohio children's alliance, which shall use the money it receives 221
under this section to pay the expenses it incurs in advancing 222
its mission of sustainably improving the provision of services 223
to children, young adults, and families in this state. 224

The registrar shall pay the contributions the registrar 225
receives pursuant to section 4503.529 of the Revised Code to the 226
Ohio nurses foundation. The foundation shall use the money it 227
receives under this section to provide educational scholarships 228
to assist individuals who aspire to join the nursing profession, 229
to assist nurses in the nursing profession who seek to advance 230
their education, and to support persons conducting nursing 231
research concerning the evidence-based practice of nursing and 232
the improvement of patient outcomes. 233

The registrar shall pay the contributions the registrar 234
receives pursuant to section 4503.53 of the Revised Code to the 235
Indiana Kentucky Ohio regional council of carpenters. The 236
council shall use the money it receives to assist its members 237
who are experiencing financial hardship. 238

The registrar shall pay the contributions the registrar 239
receives pursuant to section 4503.531 of the Revised Code to the 240
thank you foundation, incorporated, a nonprofit corporation 241
organized under the laws of this state, to assist that 242
organization in paying for the charitable activities and 243
programs it sponsors in support of United States military 244
personnel, veterans, and their families. 245

The registrar shall pay the contributions the registrar 246
receives pursuant to section 4503.532 of the Revised Code to the 247
Ohio history connection, which shall use the contributions for 248
the benefit of the Paul Laurence Dunbar house. 249

The registrar shall pay the contributions the registrar 250
receives pursuant to section 4503.533 of the Revised Code to the 251
nonprofit organization Ohio conference of teamsters and industry 252
health and welfare fund, which shall use the contributions to 253
further the nonprofit's mission. 254

The registrar shall pay the contributions the registrar 255
receives pursuant to section 4503.534 of the Revised Code to the 256
disabled American veterans department of Ohio, to be used for 257
programs that serve disabled American veterans and their 258
families. 259

The registrar shall pay the contributions the registrar 260
receives pursuant to section 4503.536 of the Revised Code to 261
save a warrior, incorporated, which shall use the contributions 262
to prevent suicide by active members of the armed forces of the 263
United States, veterans of those armed forces, and first 264
responders. 265

The registrar shall pay the contributions the registrar 266
receives pursuant to section 4503.542 of the Revised Code to the 267
Ohio craft brewers association. 268

The registrar shall pay the contributions the registrar 269
receives pursuant to section 4503.541 of the Revised Code to 270
Dolly Parton's imagination library of Ohio. The library shall 271
use the money it receives under this section for operational 272
costs, including the distribution of books. 273

The registrar shall pay the contributions that are paid to 274
the registrar pursuant to section 4503.545 of the Revised Code 275
to the national rifle association foundation, which shall use 276
the money to pay the costs of the educational activities and 277
programs the foundation holds or sponsors in this state. 278

The registrar shall pay the contributions the registrar receives pursuant to section 4503.55 of the Revised Code to the pro football hall of fame, which shall deposit the contributions into a special bank account that it establishes and which shall be separate and distinct from any other account the pro football hall of fame maintains, to be used exclusively for the purpose of promoting the pro football hall of fame as a travel destination.

The registrar shall pay to the Ohio pet fund the contributions the registrar receives pursuant to section 4503.551 of the Revised Code and any other money from any other source, including donations, gifts, and grants, that is designated by the source to be paid to the Ohio pet fund. The Ohio pet fund shall use the moneys it receives under this section to support programs for the sterilization of dogs and cats and for educational programs concerning the proper veterinary care of those animals, and for expenses of the Ohio pet fund that are reasonably necessary for it to obtain and maintain its tax-exempt status and to perform its duties.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.552 of the Revised Code to the rock and roll hall of fame and museum, incorporated.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.553 of the Revised Code to the Ohio coalition for animals, incorporated, a nonprofit corporation. Except as provided in division (B) of this section, the coalition shall distribute the money to its members, and the members shall use the money only to pay for educational, charitable, and other programs of each coalition member that provide care for unwanted, abused, and neglected horses. The

Ohio coalition for animals may use a portion of the money to pay 309
for reasonable marketing costs incurred in the design and 310
promotion of the license plate and for administrative costs 311
incurred in the disbursement and management of funds received 312
under this section. 313

The registrar shall pay the contributions the registrar 314
receives pursuant to section 4503.554 of the Revised Code to the 315
Ohio state council of the knights of Columbus, which shall use 316
the contributions to pay for its charitable activities and 317
programs. 318

The registrar shall pay the contributions the registrar 319
receives pursuant to section 4503.555 of the Revised Code to the 320
western reserve historical society, which shall use the 321
contributions to fund the Crawford auto aviation museum. 322

The registrar shall pay the contributions the registrar 323
receives pursuant to section 4503.556 of the Revised Code to the 324
Erica J. Holloman foundation, inc., for the awareness of triple 325
negative breast cancer. The foundation shall use the 326
contributions for charitable and educational purposes. 327

The registrar shall pay each contribution the registrar 328
receives pursuant to section 4503.557 of the Revised Code to the 329
central Ohio chapter of the Ronald McDonald house charities, 330
which shall distribute the contribution to the chapter of the 331
Ronald McDonald house charities in whose geographic territory 332
the person who paid the contribution resides. 333

The registrar shall pay the contributions the registrar 334
receives pursuant to section 4503.559 of the Revised Code to 335
playhouse square, located in Cleveland, Ohio, which shall use 336
the contributions to further its mission of presenting and 337

producing a wide variety of quality performing arts, advancing 338
arts education, and creating a superior destination for 339
entertainment, business, and residential living. 340

The registrar shall pay the contributions the registrar 341
receives pursuant to section 4503.561 of the Revised Code to the 342
state of Ohio chapter of ducks unlimited, inc., which shall 343
deposit the contributions into a special bank account that it 344
establishes. The special bank account shall be separate and 345
distinct from any other account the state of Ohio chapter of 346
ducks unlimited, inc., maintains and shall be used exclusively 347
for the purpose of protecting, enhancing, restoring, and 348
managing wetlands and conserving wildlife habitat. The state of 349
Ohio chapter of ducks unlimited, inc., annually shall notify the 350
registrar in writing of the name, address, and account to which 351
such payments are to be made. 352

The registrar shall pay the contributions the registrar 353
receives pursuant to section 4503.562 of the Revised Code to the 354
Mahoning river consortium, which shall use the money to pay the 355
expenses it incurs in restoring and maintaining the Mahoning 356
river watershed. 357

The registrar shall pay the contributions the registrar 358
receives pursuant to section 4503.564 of the Revised Code to the 359
Glen Helen association to pay expenses related to the Glen Helen 360
nature preserve. 361

The registrar shall pay the contributions the registrar 362
receives pursuant to section 4503.565 of the Revised Code to the 363
conservancy for Cuyahoga valley national park, which shall use 364
the money in support of the park. 365

The registrar shall pay the contributions the registrar 366

receives pursuant to section 4503.566 of the Revised Code to the 367
Ottawa national wildlife refuge, which shall use the 368
contributions for wildlife preservation purposes. 369

The registrar shall pay the contributions the registrar 370
receives pursuant to section 4503.567 of the Revised Code to the 371
girls on the run of Franklin county, inc., which shall use the 372
contributions to support the activities of the organization. 373

The registrar shall pay the contributions the registrar 374
receives pursuant to section 4503.569 of the Revised Code to the 375
Ohio bird sanctuary, located in Mansfield, Ohio, which shall use 376
the contributions for purposes of its operations, bird care and 377
rehabilitation, and educational programs. 378

The registrar shall pay the contributions the registrar 379
receives pursuant to section 4503.576 of the Revised Code to the 380
Ohio state beekeepers association, which shall use those 381
contributions to promote beekeeping, provide educational 382
information about beekeeping, and to support other state and 383
local beekeeping programs. 384

The registrar shall pay the contributions the registrar 385
receives pursuant to section 4503.577 of the Revised Code to the 386
national aviation hall of fame, which shall use the 387
contributions to fulfill its mission of honoring aerospace 388
legends to inspire future leaders. 389

The registrar shall pay the contributions the registrar 390
receives pursuant to section 4503.578 of the Revised Code to 391
keep Ohio beautiful, incorporated, which shall use the 392
contributions towards its mission of empowering Ohio communities 393
to take greater responsibility for improving the local 394
environment through litter prevention, beautification, community 395

greening, waste reduction, and recycling. 396

The registrar shall pay the contributions the registrar 397
receives pursuant to section 4503.579 of the Revised Code to the 398
Ohio state coalition-national council of negro women, 399
incorporated, which shall use the contributions for educational 400
purposes. 401

The registrar shall pay the contributions the registrar 402
receives pursuant to section 4503.581 of the Revised Code to the 403
Ohio past detachment commander's club, inc., which shall use the 404
contributions to support the activities of the organization. 405

The registrar shall pay the contributions the registrar 406
receives pursuant to section 4503.582 of the Revised Code to the 407
progressive animal welfare society adoption center, inc., which 408
shall use the contributions to support the activities of the 409
center. 410

The registrar shall pay the contributions the registrar 411
receives pursuant to section 4503.583 of the Revised Code to the 412
American legion, department of Ohio, inc., which shall use the 413
contributions to support the activities of the organization. 414

The registrar shall pay the contributions the registrar 415
receives, or has received, pursuant to section 4503.584 of the 416
Revised Code to the Ohio natural energy foundation to fund 417
scholarships for students pursuing careers in the oil and 418
natural gas industry. 419

The registrar shall pay the contributions the registrar 420
receives pursuant to section 4503.585 of the Revised Code to the 421
Terrace Park recreation committee, inc. to offer scholarships to 422
young athletes of, and maintain athletic facilities in, the 423
municipal corporation of Terrace Park. 424

The registrar shall pay the contributions the registrar 425
receives pursuant to section 4503.586 of the Revised Code to the 426
Ohio mountain bike alliance. 427

The registrar shall pay the contributions the registrar 428
receives pursuant to section 4503.588 of the Revised Code to the 429
Ohio grange patrons of husbandry foundation, which shall use the 430
contributions to support the activities of the organization. 431

The registrar shall pay to a sports commission created 432
pursuant to section 4503.591 of the Revised Code each 433
contribution the registrar receives under that section that an 434
applicant pays to obtain license plates that bear the logo of a 435
professional sports team located in the county of that sports 436
commission and that is participating in the license plate 437
program pursuant to division (E) of that section, irrespective 438
of the county of residence of an applicant. 439

The registrar shall pay to a community charity each 440
contribution the registrar receives under section 4503.591 of 441
the Revised Code that an applicant pays to obtain license plates 442
that bear the logo of a professional sports team that is 443
participating in the license plate program pursuant to division 444
(G) of that section. 445

The registrar shall pay the contributions the registrar 446
receives pursuant to section 4503.592 of the Revised Code to 447
pollinator partnership's monarch wings across Ohio program, 448
which shall use the contributions for the protection and 449
preservation of the monarch butterfly and pollinator corridor in 450
Ohio and for educational programs. 451

The registrar shall pay the contributions the registrar 452
receives pursuant to section 4503.594 of the Revised Code to 453

pelotonia, which shall use the contributions for the purpose of 454
supporting cancer research. 455

The registrar shall pay the contributions the registrar 456
receives pursuant to section 4503.595 of the Revised Code to the 457
Stan Hywet hall and gardens. 458

The registrar shall pay the contributions the registrar 459
receives pursuant to section 4503.596 of the Revised Code to the 460
Cuyahoga valley scenic railroad. 461

The registrar shall pay the contributions the registrar 462
receives pursuant to section 4503.597 of the Revised Code to the 463
Circleville pumpkin show, incorporated, which shall use the 464
contributions to promote good will surrounding the Circleville 465
pumpkin show as a nonprofit annual event. 466

The registrar shall pay the contributions the registrar 467
receives pursuant to section 4503.598 of the Revised Code 468
equally to the Jackson local schools foundation and the Jackson 469
high school alumni association. The foundation and alumni 470
association shall use the contributions for the foundation's and 471
alumni association's purposes. 472

The registrar shall pay the contributions the registrar 473
receives pursuant to section 4503.67 of the Revised Code to the 474
Dan Beard council of the boy scouts of America. The council 475
shall distribute all contributions in an equitable manner 476
throughout the state to regional councils of the boy scouts. 477

The registrar shall pay the contributions the registrar 478
receives pursuant to section 4503.68 of the Revised Code to the 479
girl scouts of Ohio's heartland. The girl scouts of Ohio's 480
heartland shall distribute all contributions in an equitable 481
manner throughout the state to regional councils of the girl 482

scouts. 483

The registrar shall pay the contributions the registrar 484
receives pursuant to section 4503.69 of the Revised Code to the 485
Dan Beard council of the boy scouts of America. The council 486
shall distribute all contributions in an equitable manner 487
throughout the state to regional councils of the boy scouts. 488

The registrar shall pay the contributions the registrar 489
receives pursuant to section 4503.70 of the Revised Code to the 490
charitable foundation of the grand lodge of Ohio, f. & a. m., 491
which shall use the contributions for scholarship purposes. 492

The registrar shall pay the contributions the registrar 493
receives pursuant to section 4503.701 of the Revised Code to the 494
Prince Hall grand lodge of free and accepted masons of Ohio, 495
which shall use the contributions for scholarship purposes. 496

The registrar shall pay the contributions the registrar 497
receives pursuant to section 4503.702 of the Revised Code to the 498
