Cost-sharing requirements - \$50 caps on supplemental 47
breast cancer screening and diagnostic breast examinations 48

R.C. 1751.62, 3923.52, and 3923.53 49

Authorizes health insuring corporations, sickness and 50
accident insurers, and public employment benefit plans to impose 51
cost-sharing requirements for supplemental breast cancer 52
screenings and diagnostic breast examinations, but limits the 53
amount of each cost-sharing requirement to \$50. (Maintains bill 54
provisions prohibiting cost-sharing requirements for screening 55
mammography and cytologic screening.) 56

Cost-sharing requirements - Waived or refunded payments 57
following breast cancer detection 58

R.C. 1751.62, 3923.52, and 3923.53 59

Requires a health insuring corporation, sickness and 60
accident insurer, or public employment benefit plan imposing the 61
foregoing cost-sharing requirement on a supplemental breast 62
cancer screening or diagnostic breast examination to do the 63
following when breast cancer is detected as a result of the 64
screening or examination: (1) waive the cost-sharing requirement 65
and (2) refund any cost-sharing amount paid. 66
