To enact section 3333.89 of the Revised Code to 1
enact the Clinical Teaching Subsidy Reform Act 2
regarding the state university clinical teaching 3
subsidy. 4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3333.89 of the Revised Code be 5
enacted to read as follows: 6

Sec. 3333.89. (A) As used in this section, "public medical 7
school" means all of the following: 8

(1) The Ohio state university college of medicine; 9

(2) The university of Cincinnati college of medicine; 10

(3) The Ohio university heritage college of osteopathic 11
medicine; 12

(4) The Wright state university Boonshoft school of 13
medicine; 14

(5) Northeast Ohio medical university; 15

(6) The university of Toledo college of medicine and life 16
sciences. 17

(B) The chancellor of higher education annually shall use 18

funds appropriated by the general assembly to distribute a 19
clinical teaching subsidy to public medical schools to support 20
clinical instruction and the education of physicians in this 21
state. The chancellor shall distribute the subsidy to public 22
medical schools using a formula that does both of the following: 23

(1) Allocates ninety per cent of the subsidy 24
proportionally among the schools based on the number of full- 25
time equivalent students enrolled in clinical training years; 26

(2) Allocates ten per cent of the subsidy among the 27
schools based on whether a school met performance metrics that 28
reflect the school's contribution to the development and 29
retention of physicians in this state, which may include the 30
following: 31

(a) The percentage of students who are residents of this 32
state; 33

(b) The percentage of graduates entering medical residency 34
programs in this state; 35

(c) The percentage of graduates practicing medicine in 36
this state three years after graduating. 37

(C) The chancellor annually shall publish all of the 38
following: 39

(1) The number of qualifying full-time equivalent students 40
enrolled in each public medical school; 41

(2) The performance metrics included in the formula to 42
distribute the clinical teaching subsidy, and the performance of 43
each public medical school on those metrics; 44

(3) The final subsidy allocation to each public medical 45
school. 46

(D) (1) Each public medical school annually shall report to 47
the chancellor, in a form and manner prescribed by the 48
chancellor, all of the following: 49

(a) How the public medical school used its clinical 50
teaching subsidy funds; 51

(b) Clinical training sites and rotation placements; 52

(c) Student residency match outcomes; 53

(d) Workforce retention statistics. 54

(2) The chancellor shall review reports submitted under 55
division (D) of this section to ensure that each public medical 56
school is using its portion of the clinical teaching subsidy to 57
provide clinical instruction and educate physicians. 58

(E) The chancellor shall adopt rules in accordance with 59
Chapter 119. of the Revised Code to administer and enforce this 60
section. The chancellor shall include all of the following in 61
the rules: 62

(1) A definition of clinical year that is consistent with 63
the definition used when determining the state share of 64
instruction appropriation for professional-level medical 65
students in the main operating appropriations act; 66

(2) A definition of qualifying full-time equivalent 67
student; 68

(3) Data submission procedures; 69

(4) Authorized performance metrics and data sources. 70

Section 2. Section 1 of this act takes effect on July 1, 71
2026. 72

Section 3. This act shall be known as the Clinical 73

Teaching Subsidy Reform Act.
