To enact section 4503.717 of the Revised Code to 1 create the "Blue Knights L.E.M.C." license 2 plate. 3

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4503.717 of the Revised Code be	4
enacted to read as follows:	5
Sec. 4503.717. (A) The owner or lessee of any passenger	6
car, noncommercial motor vehicle, motorcycle, recreational	7
vehicle, trailer, or other vehicle of a class approved by the	8
registrar of motor vehicles may apply to the registrar for the	9
registration of the vehicle and issuance of "Blue Knights	10
L.E.M.C." license plates. The application may be combined with a	11
request for a special reserved license plate under section	12
4503.40 or 4503.42 of the Revised Code. Upon receipt of the	13
completed application and compliance by the applicant with	14
divisions (B) and (C) of this section, the registrar shall issue	15
to the applicant the appropriate vehicle registration and a set	16
of "Blue Knights L.E.M.C." license plates and a validation	17
sticker, or a validation sticker alone when required by section	18
4503.191 of the Revised Code.	19

In addition to the letters and numbers ordinarily	20
inscribed on the license plates, "Blue Knights L.E.M.C." license	21
plates shall display an appropriate logo and words that are	22
selected by representatives of the Blue Knights International	23
Law Enforcement Motorcycle Club and approved by the registrar.	24
"Blue Knights L.E.M.C." license plates shall display county	25
identification stickers that identify the county of registration	26
as required under section 4503.19 of the Revised Code.	27
(B) "Blue Knights L.E.M.C." license plates and a	28
validation sticker, or validation sticker alone, shall be issued	29
upon receipt of an application for registration of a motor	30
vehicle under this section; payment of the regular license tax	31
as prescribed under section 4503.04 of the Revised Code, any	32
applicable motor vehicle license tax levied under Chapter 4504.	33
of the Revised Code, any applicable additional fee prescribed by	34
section 4503.40 or 4503.42 of the Revised Code, and an	35
additional administrative fee of ten dollars; and compliance	36
with all other applicable laws relating to the registration of	37
motor vehicles.	38
(C) The registrar shall deposit the administrative fee of	39
ten dollars, the purpose of which is to compensate the bureau of	40
motor vehicles for additional services required in the issuing	41
of "Blue Knights L.E.M.C." license plates, into the state	42
treasury to the credit of the public safety - highway purposes	43
fund created in section 4501.06 of the Revised Code.	44
