To enact sections 5.2322, 5.2411, 5.2412, 5.2413,	1
5.2414, 5.2415, and 5.268 of the Revised Code to	2
make specified day and week designations	3
relating to agriculture and to name this act the	4
Agriculture Appreciation Act.	5

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 5.2322, 5.2411, 5.2412, 5.2413,	6
5.2414, 5.2415, and 5.268 of the Revised Code be enacted to read	7
as follows:	8

<u>as "National Farmers Market Week."</u>	21
<u>Sec. 5.268. The second full week of November is designated</u>	22
<u>"Ohio Soil Health Week," to celebrate and raise awareness for</u>	23
<u>the importance of soil health to Ohio agriculture and in honor</u>	24
<u>of the birthday of soil pioneer and advocate David Brandt.</u>	25
