Education to support higher education institutions that are

may consult with the Director of Veterans Services as needed.

(B) Of the foregoing appropriation item 235450, Military 19 and Veterans Offices, up to \$213,750 in each fiscal year shall 20 be used by the Chancellor to provide awards of \$2,500 per 21 student to up to six students serving as a Military Community 2.2 Advocate at an Ohio Veterans Education Council-member public 23 university and up to three students serving as a Military 24 Community Advocate at an Ohio Veterans Education Council-member 25 public community college or private nonprofit university or 26 college. 27

(C) Of the foregoing appropriation item 235450, Military
28 and Veterans Offices, \$255,000 in each fiscal year shall be used
29 for grants for military and veterans offices at institutions of
30 higher education to support growth in private philanthropy, in
31 collaboration with the National Veterans Leadership Foundation.

(D) Of the foregoing appropriation item 235450, Military
and Veterans Offices, \$91,800 in each fiscal year shall be used
