(c) It is owned, operated, collected, preserved, restored, 10  
maintained, or used primarily as a collector's item, leisure pursuit, or 11  
investment rather than as the owner's primary means of transportation. 12

(5) "Owner" includes any person or entity that has title to a motor 13  
vehicle." 14
