"Section 265.239. PERFORMANCE SUPPLEMENT 32

(A) As used in this section, "traditional school district" 33
 means a city, local, or exempted village school district. 34

(B) For fiscal years 2026 and 2027, the Department of 35
 Education and Workforce shall pay each traditional school 36
 district a per-pupil performance supplement, as follows: 37

(1) The Department shall determine whether a district is 38
 eligible for the supplement based on whether the district 39
 received any of the following on the state report card issued 40
 under section 3302.03 of the Revised Code for the 2024-2025 41

school year for fiscal year 2026, or the 2025-2026 school year 42
for fiscal year 2027: 43

(a) An overall performance rating of four or more stars; 44

(b) A performance rating of three or more stars for the 45
Progress component; 46

(c) A higher performance rating on the Progress component 47
than the district received for that component on the state 48
report card issued for the 2023-2024 school year for fiscal year 49
2026, or the 2024-2025 school year for fiscal year 2027. 50

(2) The Department shall calculate and pay the supplement 51
to an eligible district for a fiscal year, as follows: 52

The district's enrolled ADM for the fiscal year X \$13 X the 53
greater of the number of stars the district received for either 54
the overall performance rating or the performance rating for the 55
Progress component on the state report card for the 2024-2025 56
school year for fiscal year 2026, or the 2025-2026 school year 57
for fiscal year 2027" 58

School funding supplements 60

Sections 265.237 and 265.239 61

Restores the House version's base funding supplement for 62
traditional school districts, joint vocational school districts, 63
community schools, and STEM schools, but increases the per pupil 64

amount used to calculate the supplement from \$20 to \$27 in FY 65
2026 and from \$30 to \$40 in FY 2027. 66

Revises the Senate version's performance supplement for 67
traditional school districts, as follows: 68

(1) Decreases the per pupil amount used to calculate the 69
supplement from \$26 to \$13; 70

(2) Requires DEW, when using the state report card to 71
determine a district's eligibility and calculate the supplement, 72
to use the state report card for the 2024-2025 school year for 73
FY 2026 and for the 2025-2026 school year for FY 2027, rather 74
than for the 2023-2024 school year for both fiscal years; and 75

(3) Requires the eligibility criteria to include whether a 76
district received a higher performance rating on the Progress 77
component compared to the state report card for the 2023-2024 78
school year for FY 2026 and the 2024-2025 school year for FY 79
2027, rather than for the 2022-2023 school for both fiscal 80
years. 81

Removes the requirement that the FY 2025 data for 84
economically disadvantaged student ADM used to calculate 85
disadvantaged pupil impact aid funding be taken as of June 1, 86
2025. 87

Decreases the per-student facilities payment for brick- 90
and-mortar community and STEM schools from \$1,100 in FY 2026 and 91

\$1,200 in FY 2027, as in the Senate version, to \$1,000 in each	92
fiscal year.	93

Sections 265.10 and 265.210	95
Increases GRF ALI 200550, Foundation Funding - All	96
Students, by \$9,000,000 in FY 2026, and decreases the same ALI	97
by \$9,000,000 in FY 2027.	98

Students, by \$9,000,000 in FY 2026 and \$18,000,000 in FY 2027.	100
