A CONCURRENT RESOLUTION

Authorizing a joint convention of the Ohio General 1
Assembly for the purpose of receiving a message 2
from the Governor and calling for a committee to 3
wait upon the Governor in anticipation of his 4
State of the State Address. 5

**BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF
OHIO (THE SENATE CONCURRING):**

WHEREAS, The Ohio General Assembly adopted H.C.R. No. 36 of the 6
136th General Assembly, authorizing a joint convention of the 7
legislature; and 8

WHEREAS, The Governor and legislature have determined to change 9
the date of the joint convention; and 10

WHEREAS, The members of the 136th General Assembly of Ohio, by 11
adoption of this Resolution, call for a joint convention of the 12
legislature, to be held in the House Chambers of the Ohio Statehouse, 13
March 10, 2026, at 12:00 o'clock p.m.; and 14

WHEREAS, The Ohio General Assembly annually convenes a joint 15
convention of the House and Senate for the purpose of receiving a 16
message from the Governor as to the State of the State; and 17

WHEREAS, The members of the 136th General Assembly of Ohio, by 18
adoption of the Resolution, call for the committee of nine on the part 19
of the House of Representatives and eight on the part of the Senate 20

which was previously appointed, pursuant to H.C.R. No. 36 of the 136th 21
General Assembly, to wait upon the Governor in anticipation of his 22
State of the State Address, March 10, 2026, at 12:00 o'clock p.m.; and 23

WHEREAS, It is a tradition of courtesy for the Ohio General 24
Assembly to appoint a committee to wait upon the Governor; therefore 25
be it 26

RESOLVED, That we, the members of the 136th General Assembly of 27
Ohio, in adopting this Resolution, authorize a joint convention of the 28
legislature to be held in the House Chambers of the Ohio Statehouse, 29
Columbus, March 10, 2026, at 12:00 o'clock p.m., for the purpose of 30
welcoming the Governor, the Honorable Mike DeWine, and receiving his 31
message on the State of the State; and be it further 32

RESOLVED, That we, the members of the 136th General Assembly of 33
Ohio, in adopting this Resolution, call for the committee of nine on 34
the part of the House of Representatives and eight on the part of the 35
Senate which was previously appointed, pursuant to H.C.R. No. 36 of 36
the 136th General Assembly, to wait upon the Governor; and be it 37
further 38

RESOLVED, That the rules and customs of the House shall be 39
observed during the use of the House Chambers; and be it further 40

RESOLVED, That the Clerk of the House of Representatives transmit 41
duly authenticated copies of this Resolution to Governor Mike DeWine 42
and to the news media of Ohio. 43
