BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO:

WHEREAS, Special Olympics is a global sports movement that
unleashes the human spirit every day around the world through
the transformative power and joy of sport; and

WHEREAS, The Special Olympics U.S.A. Games celebrate
athletes with intellectual disabilities by focusing on
inclusivity, empowerment, and community through diverse sports
competitions and supportive programs; and

WHEREAS, The mission of Special Olympics is to provide
year-round sports training and athletic competition in a variety
of Olympic-type sports for children and adults with intellectual
disabilities, giving them continuing opportunities to develop
physical fitness, demonstrate courage, experience joy, and
participate in a sharing of gifts, skills, and friendship with

WHEREAS, The City of Cleveland is a top contender to host 18
the 2030 games; and 19

WHEREAS, The Special Olympics U.S.A. Site Selection 20
Committee has toured the city and the venues that would be 21
involved with hosting the games in 2030; and 22

WHEREAS, The final decision to be announced this spring is 23
down to Cleveland or Nashville; and 24

WHEREAS, The Greater Cleveland Sports Commission has 25
already recruited over 10,000 volunteers five years out; and 26

WHEREAS, The money raised already from corporate leaders, 27
over \$10 million, is unprecedented, and shows an extreme 28
commitment from the community; now therefore be it 29
