operator in International Union of Operating Engineers Local 18, 12 working for Skidmore and Chah, a co-owner with his wife of the Red 13 Barn Sweet Corn and Produce Market, and a parishioner of Andover 14 United Methodist Church, and he served his fellow citizens as a 15 trustee for Andover Township and a member of the Pymatuning Valley 16 Local School Board and the Ohio House of Representatives, holding this 17 post from 1983 to 1999 and attaining the rank of Minority Leader. 18 Indeed, his love for Ohio and his sincere desire to serve its people 19 to the best of his ability have shown him to be a truly concerned and 20 responsible public servant; and 21

WHEREAS, Ross Boggs' regard for improving the quality of life in 22 our society was clearly evident in his personal sacrifices of time and 23 effort to his family, friends, and community. Although the void his death has created 33 can never be filled, the legacy of care and commitment he established 34 will surely live on.
