Code to regulate the ownership of electric

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

To enact sections 4933.51, 4933.53, 4933.54,

Section 1. That sections 4933.51, 4933.53, 4933.54,	5
4933.55, 4933.57, and 4933.59 of the Revised Code be enacted to	6

Sec. 4933.51. As used in sections 4933.51 to 4933.59 of	8
the Revised Code:	9
(A) "Area of last resort" means an area within an electric	10
distribution utility's designated service territory that is	11
located in a county of this state with a population of not more	12
than fifty thousand, but excluding any areas of the county that	13
are within a ten-mile radius of another publicly available	14
electric vehicle charging station or any areas of the county	15
that are within one mile of an alternative fuel corridor	16
designated by the federal highway administration.	17
(B) "Direct current fast charging station" means an	18
electric vehicle charging system capable of distributing	19

electricity at fifty kilowatts or more of direct current to an	20
electric vehicle's rechargeable battery at a voltage of two	21
hundred volts or more.	22
(C) "Electric distribution utility" has the same meaning	23
as in section 4928.01 of the Revised Code.	24
(D) "Electric vehicle" means a vehicle that is powered	25
wholly by a system that can be recharged via an external source	26
of electricity, including a vehicle for public or private use	27
that is a passenger car, commercial car or truck, a vehicle used	28
for public transit, a vehicle used in a vehicle fleet, a vehicle	29
used in construction work, and a vehicle used in industrial or	30
warehouse work.	31
(E) "Electric vehicle charging provider" means the owner	32
or operator of an electric vehicle charging station. "Electric	33
vehicle charging provider" excludes either of the following that	34
owns or operates an electric vehicle charging station:	35
(1) An electric distribution utility;	36
(2) An affiliate or subsidiary of an electric distribution	37
utility.	38
(F) "Electric vehicle charging station" means any	39
nonresidential electric vehicle charging system that is both of	40
the following:	41
(1) Capable of distributing electricity from a source	42
outside an electric vehicle to the electric vehicle;	43
(2) A direct current fast charging station or level two	44
charging station.	45
(G) "Level two charging station" means any electric	46
vehicle charging system capable of distributing electricity at a	47

minimum of three or a maximum of twenty kilowatts of alternating	48
current to an electric vehicle's rechargeable battery at a	49
voltage of two hundred volts or more.	50
(H) "Make-ready infrastructure" means electrical	51
infrastructure required to accommodate the electric load of an	52
electric vehicle charging station. "Make-ready infrastructure"	53
excludes an electric vehicle charging station.	54
Sec. 4933.53. (A) No electric distribution utility may own	55
or operate publicly available electric vehicle charging stations	56
except through a separate affiliate or subsidiary that is not	57
subject to public utilities commission jurisdiction, except as	58
provided in division (C) of this section and notwithstanding	59
section 4933.55 of the Revised Code. This division does not	60
prohibit the commission from approving a program, funded by	61
revenues from electric distribution utility rates, to promote	62
the creation of electric vehicle charging stations by electric	63
vehicle charging providers or the purchase of any equipment used	64
to charge an electric vehicle by residential customers.	65
(B)(1) No electric distribution utility may charge its	66
affiliate or subsidiary a subsidized rate, fee, or charge for	67
electric service distributed to the affiliate's or subsidiary's	68
publicly available electric vehicle charging stations.	69
(2) An electric distribution utility affiliate or	70
subsidiary that owns or operates an electric vehicle charging	71
station shall be subject to the same rates, terms, and	72
conditions that apply to electric vehicle charging providers	73
located in the electric distribution utility's certified	74
territory.	75
(C)(1) If, five or more years after the effective date of	76

this section, an electric distribution utility is able to	77
demonstrate that there is not at least one publicly available	78
electric vehicle charging station in an area of last resort, the	79
electric distribution utility may petition the commission for	80
approval of the installation and ownership of a publicly	81
available electric vehicle charging station solely in the area	82
of last resort.	83
The commission may approve, modify and approve, or reject	84
an electric distribution utility's installation and ownership of	85
such a charging station in an area of last resort, provided that	86
any approval shall include a finding that the requirements of	87
this section and section 4933.54 of the Revised Code have been	88
met.	89
(2) No electric distribution utility shall be obligated to	90
deploy equipment for a publicly available electric vehicle	91
charging station without timely and adequate cost recovery.	92
(D)(1) If an electric distribution utility files a	93
petition under division (C) of this section, the electric	94
distribution utility also shall file a proposal with the	95
commission that includes a description of the area of last	96
resort, a statement certifying that there is not at least one	97
publicly available electric vehicle charging station in the area	98
of last resort, and a description of the publicly available	99
electric vehicle charging station it proposes to construct at	100
the location.	101
(2) An electric distribution utility, concurrently with	102
the filing made under this division, shall provide conspicuous	103
public notice on the electric distribution utility's web site	104
and to each dealer of transportation fuel within a ten-mile	105
radius of the location of the electric distribution utility's	106

proposed publicly available electric vehicle charging station.	107
Such notice shall contain at least both of the following:	108
(a) The date the electric distribution utility filed a	109
proposal with the commission to provide a publicly available	110
electric vehicle charging station under this division;	111
(b) The date by which a person may file a proposal to	112
provide a publicly available electric vehicle charging station	113
within a ten-mile radius of the proposed location as described	114
in section 4933.54 of the Revised Code.	115
(E) Prior to approving an electric distribution utility's	116
installation and ownership of an electric vehicle charging	117
station under division (C) of this section, the commission shall	118
conduct a right of first refusal process. The commission shall	119
not conduct a right of first refusal process if there is a	120
publicly available electric vehicle charging station within a	121
ten-mile radius of the site where an electric distribution	122
utility proposes to locate such a charging station.	123
(F) If, within ninety days after notice is provided under	124
division (D) of this section, no electric vehicle charging	125
providers are identified within ten miles of the location	126
proposed by an electric distribution utility in a proposal filed	127
under division (D) of this section, an electric distribution	128
utility may submit to the commission a notice of intent to	129
proceed with installation of a publicly available electric	130
vehicle charging station.	131
(G) Not earlier than one hundred eighty days after the	132
commission's finding of public interest and approval of the	133
proposal and installation, an electric distribution utility may	134
proceed with the construction and operation of its proposed	135

publicly available electric vehicle charging station. The	136
construction and operation of the charging station shall not	137
proceed if the commission determines that the construction and	138
operation unreasonably duplicates a publicly available electric	139
vehicle charging station operated, or under construction, by	140
another person.	141
Sec. 4933.54. Not later than ninety days after the filing	142
and notice described in division (D) of section 4933.53 of the	143
Revised Code, any person, except an electric distribution	144
utility, an electric cooperative, or a municipal electric	145
utility, may submit a notice to the public utilities commission	146
stating that it intends to provide a publicly available electric	147
vehicle charging station within a ten-mile radius of the	148
location proposed by an electric distribution utility under	149
section 4933.53 of the Revised Code and intends to request the	150
necessary make-ready infrastructure from the electric	151
distribution utility. The notice shall include the person's firm	152
commitment to place the charging station into service before the	153
later of the following dates:	154
(A) Eighteen months after the date the person submits the	155
notice to the commission;	156
(B) Twelve months after the date of completion of the	157
installation of the necessary make-ready infrastructure.	158

distribution utility for providing electric distribution service	160
shall not, directly or indirectly, subsidize investments in the	161
ownership or operation of electric vehicle charging stations,	162
except as part of a program approved by the public utilities	163

Revised Code.	165

Sec. 4933.57. Nothing in sections 4933.51 to 4933.59 of	166
the Revised Code prohibits an electric distribution utility from	167
recovering the costs of make-ready infrastructure through rates	168
or charges authorized under the electric distribution utility's	169
distribution rate case under section 4909.18 of the Revised	170
Code, so long as such subsidies for make-ready infrastructure	171
are offered to electric vehicle charging providers on a	172
<pre>nondiscriminatory basis.</pre>	173
Sec. 4933.59. Nothing in sections 4933.51 to 4933.59 of	174
the Revised Code shall be construed to prohibit an electric	175
distribution utility from operating, leasing, installing, or	176
otherwise procuring service from an electric vehicle charging	177
station on its own premises for the sole purpose of serving its	178
own electric vehicles.	179
