BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 341.02 and 5901.03 be amended and	5
section 341.43 of the Revised Code be enacted to read as	6
follows:	7
Sec. 341.02. The sheriff shall make the following entries	8
in a suitable book, which shall be known as the "jail register,"	9
kept in the office of the jailer, and delivered to the successor	10
in office of such jailer:	11
(A) The name of each prisoner, and the date and cause of	12
histhe prisoner's commitment;	13
(B) The date and manner of his the prisoner's discharge;	14
(C) If the prisoner is verified as a veteran as a result	15
of an investigation conducted pursuant to section 341.43 of the	16

Revised Code, the veteran status of the prisoner.	17
The sheriff or jail administrator shall prepare written	18
operational policies and procedures and prisoner rules of	19
conduct, and maintain the records prescribed by these policies	20
and procedures in accordance with the minimum standards for	21
jails in Ohio promulgated by the department of rehabilitation	22
and correction.	23
The court of common pleas shall review the jail's	24
operational policies and procedures and prisoner rules of	25
conduct. If the court approves the policies, procedures, and	26
rules of conduct, they shall be adopted.	27
Sec. 341.43. (A) All of the following institutions or	28
entities shall designate as soon as practicable at least one	29
individual to perform the duties set forth in division (B) of	30

(1) Each institution that is under the control of the	32

perform the duties set forth in divisions (B)(4) to (6) of this	48

(2) Upon determining the number of necessary individuals,	50
designate as soon as practicable that number of individuals to	51
perform the duties set forth in divisions (B)(4) to (6) of this	52
<pre>section;</pre>	53
(3) Train each designated qualified individual to use the	54
veteran's reentry search service operated by the United States	55
department of veterans affairs by seeking cost-free training	56
assistance from a representative of the veterans justice	57
outreach program operated by the department of veterans affairs	58
or other appropriate representative of the department. If an	59
institution or entity is unable to acquire cost-free assistance	60
from the department, the institution or entity may, at the	61
institution's or entity's own expense, retain individuals who	62
are knowledgeable about the veteran's reentry search service by	63

(4) Investigate and verify the veteran status of each	66
individual served by the institution or entity, appearing before	67

this section by using data provided by the veteran's reentry	72

this section, note the individual's status as a veteran on all		
appropriate records pursuant to rules adopted under division (C)

this section, assist the individual in contacting veteran-		
related services such as the department of veterans services,

(C) The director of rehabilitation and correction shall	90

Sec. 5901.03. The veterans service commission shall select	102	
one of its members as president, one as vice-president, and one	103	
as secretary. The commission shall meet at least once each		

month. A judge of the court of common pleas may remove, for	105
cause, any member of the commission appointed under section	106
5901.02 of the Revised Code, and shall fill vacancies occurring	107
among memberships appointed under that section for the unexpired	108
terms in the manner provided for the original appointments.	109
The commission's duties shall include but are not limited	110
to the following:	111
(A) Employing such staff as are necessary to carry out the	112
commission's duties, and fixing their compensation;	113
(B) Establishing policies and procedures for the	114
