BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 4501.21 and 5910.07 be amended 18

Sec. 4501.21. (A) There is hereby created in the state 29
treasury the license plate contribution fund. The fund shall 30
consist of all contributions for specialty license plates paid 31
by motor vehicle registrants and collected by the registrar of 32
motor vehicles pursuant to the Revised Code sections referenced 33
in division (B) of this section. 34

(B) The registrar shall pay the contributions the 35
registrar collects in the fund as follows: 36

The registrar shall pay the contributions received 37
pursuant to section 4503.491 of the Revised Code to the breast 38
cancer fund of Ohio, which shall use that money only to pay for 39
programs that provide assistance and education to Ohio breast 40
cancer patients and that improve access for such patients to 41
quality health care and clinical trials and shall not use any of 42
the money for abortion information, counseling, services, or 43
other abortion-related activities. 44

The registrar shall pay the contributions the registrar receives pursuant to section 4503.492 of the Revised Code to the organization cancer support community central Ohio, which shall deposit the money into the Sheryl L. Kraner Fund of that organization. Cancer support community central Ohio shall expend the money it receives pursuant to this division only in the same manner and for the same purposes as that organization expends other money in that fund.

The registrar shall pay the contributions received pursuant to section 4503.493 of the Revised Code to the autism society of Ohio, which shall use the contributions for programs and autism awareness efforts throughout the state.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.494 of the Revised Code to the national multiple sclerosis society for distribution in equal amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley chapters of the national multiple sclerosis society. These chapters shall use the money they receive under this section to assist in paying the expenses they incur in providing services directly to their clients.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.495 of the Revised Code to the national pancreatic cancer foundation, which shall use the money it receives under this section to assist those who have pancreatic cancer and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.496 of the Revised Code to the Ohio sickle cell and health association, which shall use the contributions to help support educational, clinical, and social support services for adults who have sickle cell disease.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.497 of the Revised Code to the St. Baldrick's foundation, which shall use the contributions for its research and other programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.498 of the Revised Code to special olympics Ohio, inc., which shall use the contributions for its programs, charitable efforts, and other activities.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.499 of the Revised Code to the children's glioma cancer foundation, which shall use the contributions for its research and other programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4910 of the Revised Code to the KylerStrong foundation, which shall use the contributions to raise awareness of brain cancer caused by diffuse intrinsic pontine glioma and to fund research for the cure of such cancer.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4911 of the Revised Code to the research institution for childhood cancer at nationwide children's hospital, which shall use the contributions to fund research for the cure of childhood cancers.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.4912 of the Revised Code to the Ben Morrison memorial fund, which shall use the contributions for scholarships and other programs that support mental health.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.50 of the Revised Code to the

future farmers of America foundation, which shall deposit the 104
contributions into its general account to be used for 105
educational and scholarship purposes of the future farmers of 106
America foundation. 107

The registrar shall pay the contributions the registrar 108
receives pursuant to section 4503.501 of the Revised Code to the 109
4-H youth development program of the Ohio state university 110
extension program, which shall use those contributions to pay 111
the expenses it incurs in conducting its educational activities. 112

The registrar shall pay the contributions received 113
pursuant to section 4503.502 of the Revised Code to the Ohio 114
cattlemen's foundation, which shall use those contributions for 115
scholarships and other educational activities. 116

The registrar shall pay the contributions received 117
pursuant to section 4503.505 of the Revised Code to the 118
organization Ohio region phi theta kappa, which shall use those 119
contributions for scholarships for students who are members of 120
that organization. 121

The registrar shall pay the contributions the registrar 122
receives pursuant to section 4503.506 of the Revised Code to 123
Ohio demolay, which shall use the contributions for 124
scholarships, educational programs, and any other programs or 125
events the organization holds or sponsors in this state. 126

The registrar shall pay the contributions received 127
pursuant to section 4503.507 of the Revised Code to the Ohio 128
aerospace institute, which shall use those contributions to 129
facilitate student internships in aerospace and educational 130
programming. 131

The registrar shall pay the contributions received 132

pursuant to section 4503.508 of the Revised Code to the 133
organization bottoms up diaper drive to provide funding for that 134
organization for collecting and delivering diapers to parents in 135
need. 136

The registrar shall pay the contributions the registrar 137
receives pursuant to section 4503.509 of the Revised Code to a 138
kid again, incorporated for distribution in equal amounts to the 139
Ohio chapters of a kid again. 140

The registrar shall pay each contribution the registrar 141
receives pursuant to section 4503.51 of the Revised Code to the 142
university or college whose name or marking or design appears on 143
collegiate license plates that are issued to a person under that 144
section. A university or college that receives contributions 145
from the fund shall deposit the contributions into its general 146
scholarship fund. 147

The registrar shall pay each contribution the registrar 148
receives pursuant to section 4503.512 of the Revised Code to the 149
Iota Phi Theta Fraternity, Incorporated Delta Theta Omega 150
chapter in Ohio. The Iota Phi Theta Fraternity, Incorporated 151
Delta Theta Omega chapter shall use the contributions for the 152
development and perpetuation of scholarship, leadership, 153
citizenship, fidelity, and brotherhood among men and youth in 154
this state. 155

The registrar shall pay the contributions the registrar 156
receives pursuant to section 4503.514 of the Revised Code to the 157
university of Notre Dame in South Bend, Indiana, for purposes of 158
awarding grants or scholarships to residents of Ohio who attend 159
the university. The university shall not use any of the funds it 160
receives for purposes of administering the scholarship program. 161
The registrar shall enter into appropriate agreements with the 162

university of Notre Dame to effectuate the distribution of such 163
funds as provided in this section. 164

The registrar shall pay the contributions the registrar 165
receives pursuant to section 4503.516 of the Revised Code to 166
Marshall university in Huntington, West Virginia, for purposes 167
of awarding grants or scholarships to residents of Ohio who 168
attend the university. The university shall not use any of the 169
funds it receives for purposes of administering the scholarship 170
program. The registrar shall enter into appropriate agreements 171
with Marshall university to effectuate the distribution of such 172
funds as provided in this section. 173

The registrar shall pay the contributions the registrar 174
receives pursuant to section 4503.517 of the Revised Code to the 175
university of Alabama in Tuscaloosa, Alabama, for purposes of 176
awarding grants or scholarships to residents of Ohio who attend 177
the university. The university shall not use any of the funds it 178
receives for purposes of administering the scholarship program. 179
The registrar shall enter into appropriate agreements with the 180
university of Alabama to effectuate the distribution of such 181
funds as provided in this section. 182

The registrar shall pay the contributions the registrar 183
receives pursuant to section 4503.518 of the Revised Code to the 184
Nationwide children's hospital, which shall use the 185
contributions for the "On Our Sleeves" campaign. 186

The registrar shall pay the contributions the registrar 187
receives pursuant to section 4503.519 of the Revised Code 188
equally to NAMI Ohio (national alliance on mental illness of 189
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 190
advocates for addiction recovery). 191

The registrar shall pay the contributions the registrar receives pursuant to section 4503.520 of the Revised Code to Purdue university in West Lafayette, Indiana, for purposes of awarding grants or scholarships to residents of Ohio who attend the university. The university shall not use any of the funds it receives for purposes of administering the scholarship program. The registrar shall enter into appropriate agreements with Purdue university to effectuate the distribution of such funds as provided in this section.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.521 of the Revised Code to the Ohio bicycle federation to assist that organization in paying for the educational programs it sponsors in support of Ohio cyclists of all ages.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.522 of the Revised Code to the "friends of Perry's victory and international peace memorial, incorporated," a nonprofit corporation organized under the laws of this state, to assist that organization in paying the expenses it incurs in sponsoring or holding charitable, educational, and cultural events at the monument.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.523 of the Revised Code to the fairport lights foundation, which shall use the money to pay for the restoration, maintenance, and preservation of the lighthouses of fairport harbor.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.524 of the Revised Code to the Massillon tiger football booster club, which shall use the contributions only to promote and support the football team of

Washington high school of the Massillon city school district.	222
The registrar shall pay the contributions the registrar receives pursuant to section 4503.525 of the Revised Code to the United States power squadron district seven which shall annually distribute the contributions in equal amounts to all United States power squadrons located in the state. Each power squadron district shall use the money it receives under this section to pay for the educational boating programs each district holds or sponsors within this state.	223 224 225 226 227 228 229 230
The registrar shall pay the contributions the registrar receives pursuant to section 4503.526 of the Revised Code to the Ohio district Kiwanis foundation of the Ohio district of Kiwanis international, which shall use the money it receives under this section to pay the costs of its educational and humanitarian activities.	231 232 233 234 235 236
The registrar shall pay the contributions the registrar receives pursuant to section 4503.528 of the Revised Code to the Ohio children's alliance, which shall use the money it receives under this section to pay the expenses it incurs in advancing its mission of sustainably improving the provision of services to children, young adults, and families in this state.	237 238 239 240 241 242
The registrar shall pay the contributions the registrar receives pursuant to section 4503.529 of the Revised Code to the Ohio nurses foundation. The registrar shall pay the contributions the registrar receives pursuant to section 4503.53 of the Revised Code to the Indiana Kentucky Ohio regional council of carpenters. The council shall use the money it receives to assist its members who are experiencing financial hardship.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.531 of the Revised Code to the thank you foundation, incorporated, a nonprofit corporation organized under the laws of this state, to assist that organization in paying for the charitable activities and programs it sponsors in support of United States military personnel, veterans, and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.532 of the Revised Code to the Ohio history connection, which shall use the contributions for the benefit of the Paul Laurence Dunbar house.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.533 of the Revised Code to the nonprofit organization Ohio conference of teamsters and industry health and welfare fund, which shall use the contributions to further the nonprofit's mission.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.534 of the Revised Code to the disabled American veterans department of Ohio, to be used for programs that serve disabled American veterans and their families.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.536 of the Revised Code to save a warrior, incorporated, which shall use the contributions

to prevent suicide by active members of the armed forces of the 281
United States, veterans of those armed forces, and first 282
responders. 283

The registrar shall pay the contributions the registrar 284
receives pursuant to section 4503.537 of the Revised Code to 285
lifetown, incorporated, which shall use the contributions to 286
fund its program and activities. 287

The registrar shall pay the contributions the registrar 288
receives pursuant to section 4503.542 of the Revised Code to the 289
Ohio craft brewers association. 290

The registrar shall pay the contributions the registrar 291
receives pursuant to section 4503.541 of the Revised Code to 292
Dolly Parton's imagination library of Ohio. The library shall 293
use the money it receives under this section for operational 294
costs, including the distribution of books. 295

The registrar shall pay the contributions that are paid to 296
the registrar pursuant to section 4503.545 of the Revised Code 297
to the national rifle association foundation, which shall use 298
the money to pay the costs of the educational activities and 299
programs the foundation holds or sponsors in this state. 300

The registrar shall pay the contributions the registrar 301
receives pursuant to section 4503.55 of the Revised Code to the 302
pro football hall of fame, which shall deposit the contributions 303
into a special bank account that it establishes and which shall 304
be separate and distinct from any other account the pro football 305
hall of fame maintains, to be used exclusively for the purpose 306
of promoting the pro football hall of fame as a travel 307
destination. 308

The registrar shall pay to the Ohio pet fund the 309

contributions the registrar receives pursuant to section 310
4503.551 of the Revised Code and any other money from any other 311
source, including donations, gifts, and grants, that is 312
designated by the source to be paid to the Ohio pet fund. The 313
Ohio pet fund shall use the moneys it receives under this 314
section to support programs for the sterilization of dogs and 315
cats and for educational programs concerning the proper 316
veterinary care of those animals, and for expenses of the Ohio 317
pet fund that are reasonably necessary for it to obtain and 318
maintain its tax-exempt status and to perform its duties. 319

The registrar shall pay the contributions the registrar 320
receives pursuant to section 4503.552 of the Revised Code to the 321
rock and roll hall of fame and museum, incorporated. 322

The registrar shall pay the contributions the registrar 323
receives pursuant to section 4503.553 of the Revised Code to the 324
Ohio coalition for animals, incorporated, a nonprofit 325
corporation. Except as provided in division (B) of this section, 326
the coalition shall distribute the money to its members, and the 327
members shall use the money only to pay for educational, 328
charitable, and other programs of each coalition member that 329
provide care for unwanted, abused, and neglected horses. The 330
Ohio coalition for animals may use a portion of the money to pay 331
for reasonable marketing costs incurred in the design and 332
promotion of the license plate and for administrative costs 333
incurred in the disbursement and management of funds received 334
under this section. 335

The registrar shall pay the contributions the registrar 336
receives pursuant to section 4503.554 of the Revised Code to the 337
Ohio state council of the knights of Columbus, which shall use 338
the contributions to pay for its charitable activities and 339

programs. 340

The registrar shall pay the contributions the registrar 341
receives pursuant to section 4503.555 of the Revised Code to the 342
western reserve historical society, which shall use the 343
contributions to fund the Crawford auto aviation museum. 344

The registrar shall pay the contributions the registrar 345
receives pursuant to section 4503.556 of the Revised Code to the 346
Erica J. Holloman foundation, inc., for the awareness of triple 347
negative breast cancer. The foundation shall use the 348
contributions for charitable and educational purposes. 349

The registrar shall pay each contribution the registrar 350
receives pursuant to section 4503.557 of the Revised Code to the 351
central Ohio chapter of the Ronald McDonald house charities, 352
which shall distribute the contribution to the chapter of the 353
Ronald McDonald house charities in whose geographic territory 354
the person who paid the contribution resides. 355

The registrar shall pay the contributions the registrar 356
receives pursuant to section 4503.559 of the Revised Code to 357
playhouse square, located in Cleveland, Ohio, which shall use 358
the contributions to further its mission of presenting and 359
producing a wide variety of quality performing arts, advancing 360
arts education, and creating a superior destination for 361
entertainment, business, and residential living. 362

The registrar shall pay the contributions the registrar 363
receives pursuant to section 4503.561 of the Revised Code to the 364
state of Ohio chapter of ducks unlimited, inc., which shall 365
deposit the contributions into a special bank account that it 366
establishes. The special bank account shall be separate and 367
distinct from any other account the state of Ohio chapter of 368

ducks unlimited, inc., maintains and shall be used exclusively 369
for the purpose of protecting, enhancing, restoring, and 370
managing wetlands and conserving wildlife habitat. The state of 371
Ohio chapter of ducks unlimited, inc., annually shall notify the 372
registrar in writing of the name, address, and account to which 373
such payments are to be made. 374

The registrar shall pay the contributions the registrar 375
receives pursuant to section 4503.562 of the Revised Code to the 376
Mahoning river consortium, which shall use the money to pay the 377
expenses it incurs in restoring and maintaining the Mahoning 378
river watershed. 379

The registrar shall pay the contributions the registrar 380
receives pursuant to section 4503.564 of the Revised Code to the 381
Glen Helen association to pay expenses related to the Glen Helen 382
nature preserve. 383

The registrar shall pay the contributions the registrar 384
receives pursuant to section 4503.565 of the Revised Code to the 385
conservancy for Cuyahoga valley national park, which shall use 386
the money in support of the park. 387

The registrar shall pay the contributions the registrar 388
receives pursuant to section 4503.566 of the Revised Code to the 389
Ottawa national wildlife refuge, which shall use the 390
contributions for wildlife preservation purposes. 391

The registrar shall pay the contributions the registrar 392
receives pursuant to section 4503.567 of the Revised Code to the 393
girls on the run of Franklin county, inc., which shall use the 394
contributions to support the activities of the organization. 395

The registrar shall pay the contributions the registrar 396
receives pursuant to section 4503.569 of the Revised Code to the 397

Ohio bird sanctuary, located in Mansfield, Ohio, which shall use 398
the contributions for purposes of its operations, bird care and 399
rehabilitation, and educational programs. 400

The registrar shall pay the contributions the registrar 401
receives pursuant to section 4503.576 of the Revised Code to the 402
Ohio state beekeepers association, which shall use those 403
contributions to promote beekeeping, provide educational 404
information about beekeeping, and to support other state and 405
local beekeeping programs. 406

The registrar shall pay the contributions the registrar 407
receives pursuant to section 4503.577 of the Revised Code to the 408
national aviation hall of fame, which shall use the 409
contributions to fulfill its mission of honoring aerospace 410
legends to inspire future leaders. 411

The registrar shall pay the contributions the registrar 412
receives pursuant to section 4503.578 of the Revised Code to 413
keep Ohio beautiful, incorporated, which shall use the 414
contributions towards its mission of empowering Ohio communities 415
to take greater responsibility for improving the local 416
environment through litter prevention, beautification, community 417
greening, waste reduction, and recycling. 418

The registrar shall pay the contributions the registrar 419
receives pursuant to section 4503.579 of the Revised Code to the 420
Ohio state coalition-national council of negro women, 421
incorporated, which shall use the contributions for educational 422
purposes. 423

The registrar shall pay the contributions the registrar 424
receives pursuant to section 4503.581 of the Revised Code to the 425
Ohio past detachment commander's club, inc., which shall use the 426

contributions to support the activities of the organization. 427

The registrar shall pay the contributions the registrar 428
receives pursuant to section 4503.582 of the Revised Code to the 429
progressive animal welfare society adoption center, inc., which 430
shall use the contributions to support the activities of the 431
center. 432

The registrar shall pay the contributions the registrar 433
receives pursuant to section 4503.583 of the Revised Code to the 434
American legion, department of Ohio, inc., which shall use the 435
contributions to support the activities of the organization. 436

The registrar shall pay the contributions the registrar 437
receives, or has received, pursuant to section 4503.584 of the 438
Revised Code to the Ohio natural energy foundation to fund 439
scholarships for students pursuing careers in the oil and 440
natural gas industry. 441

The registrar shall pay the contributions the registrar 442
receives pursuant to section 4503.585 of the Revised Code to the 443
Terrace Park recreation committee, inc. to offer scholarships to 444
young athletes of, and maintain athletic facilities in, the 445
municipal corporation of Terrace Park. 446

The registrar shall pay the contributions the registrar 447
receives pursuant to section 4503.586 of the Revised Code to the 448
Ohio mountain bike alliance. 449

The registrar shall pay the contributions the registrar 450
receives pursuant to section 4503.588 of the Revised Code to the 451
Ohio grange patrons of husbandry foundation, which shall use the 452
contributions to support the activities of the organization. 453

The registrar shall pay to a sports commission created 454
pursuant to section 4503.591 of the Revised Code each 455

contribution the registrar receives under that section that an 456
applicant pays to obtain license plates that bear the logo of a 457
professional sports team located in the county of that sports 458
commission and that is participating in the license plate 459
program pursuant to division (E) of that section, irrespective 460
of the county of residence of an applicant. 461

The registrar shall pay to a community charity each 462
contribution the registrar receives under section 4503.591 of 463
the Revised Code that an applicant pays to obtain license plates 464
that bear the logo of a professional sports team that is 465
participating in the license plate program pursuant to division 466
(G) of that section. 467

The registrar shall pay the contributions the registrar 468
receives pursuant to section 4503.592 of the Revised Code to 469
pollinator partnership's monarch wings across Ohio program, 470
which shall use the contributions for the protection and 471
preservation of the monarch butterfly and pollinator corridor in 472
Ohio and for educational programs. 473

The registrar shall pay the contributions the registrar 474
receives pursuant to section 4503.594 of the Revised Code to 475
pelotonia, which shall use the contributions for the purpose of 476
supporting cancer research. 477

The registrar shall pay the contributions the registrar 478
receives pursuant to section 4503.595 of the Revised Code to the 479
Stan Hywet hall and gardens. 480

The registrar shall pay the contributions the registrar 481
receives pursuant to section 4503.596 of the Revised Code to the 482
Cuyahoga valley scenic railroad. 483

The registrar shall pay the contributions the registrar 484

receives pursuant to section 4503.597 of the Revised Code to the 485
Circleville pumpkin show, incorporated, which shall use the 486
contributions to promote good will surrounding the Circleville 487
