BE IT RESOLVED BY THE SENATE OF THE STATE OF OHIO (THE HOUSE OF REPRESENTATIVES CONCURRING):

WHEREAS, According to the United States Drug Enforcement	6
Administration, fentanyl is a synthetic opioid fifty times more	7
potent than heroin and one hundred times more potent than	8
morphine; and	9
WHEREAS, According to data from the Centers for Disease	10
Control and Prevention (CDC), fentanyl has become the number one	11
cause of death for Americans eighteen to forty-five years of	12
age; and	
WHEREAS, According to the CDC, pharmaceutical fentanyl is	14
prescribed by physicians and other authorized health care	15
providers to treat severe pain, especially after surgery or for	16
advanced stage cancer, and may also be used as an anesthetic or	17
in other hospital or treatment settings legally; and	18
WHEREAS, Illicit fentanyl, both illegally made fentanyl and	19
diverted pharmaceutical fentanyl, is often distributed through	20

criminal drug markets in different forms, including liquid or	21	
powder, making its detection complex and its distinction from	22	
other drugs increasingly difficult; and	23	
WHEREAS, According to the CDC, fentanyl and drugs similar	24	
in chemical structure to fentanyl are being mixed into	25	
counterfeit opioid pills, heroin, cocaine, marijuana, and	26	
methamphetamine, and people who use only non-opioid drugs are	27	
more likely to overdose if they are exposed to drugs mixed with	28	
opioids, including fentanyl; and	29	
WHEREAS, According to the National Center for Health	30	
Statistics, overdose deaths involving synthetic opioids,	31	
primarily fentanyl, were estimated to be 74,702 in 2023; and	32	
WHEREAS, According to the Ohio Department of Health,	33	
fentanyl was involved in seventy-eight per cent of Ohio's	34	
unintentional drug overdose deaths in 2023; and	35	
WHEREAS, United States Customs and Border Protection (CBP)	36	
seized more than twenty-one thousand pounds of illicit fentanyl		
in federal fiscal year 2024; and	38	
WHEREAS, CBP's fentanyl seizures have increased more than	39	
eight hundred per cent since federal fiscal year 2019; and	40	
WHEREAS, The dangers of fentanyl are further evidenced by	41	
such events as those in 2002 when, in response to Chechen rebels	42	
taking over eight hundred hostages in a Moscow theater, Russia	43	
deployed an unknown gas, later confirmed by the Russian Health	44	
Minister to contain fentanyl-related compounds, to neutralize	45	
the rebels, which resulted in the death of 117 hostages from	46	
effects of the gas; now therefore be it	47	
RESOLVED, That we, the members of the 136th General	48	
Assembly of the State of Ohio, urge the 119th United States	49	
Congress to introduce and pass legislation that is similar to a	50	
previous proposal known as the Stop Our Scourge Act of 2023,	51
