Dear Chairman Burke, Ranking Member Antonio and members of the Committee,

On behalf of Catholics for Choice, I urge you to oppose SB 23 and its restrictions on women's access to safe, legal abortion. Catholics for Choice serves as the voice of the majority of the 70 million Catholics in the United States—nearly two million Catholics in Ohio—who support access to reproductive health services. Catholics, in full accordance with the teachings of our faith, support the right of all people to follow their own consciences when making critical moral decisions, including decisions about reproductive healthcare. Catholics agree with the majority of Americans who want healthcare decisions to be made by patients, according to their own consciences and in consultation with trusted medical professionals. Women are moral agents, and they alone know their unique circumstances and the results of their actions. Therefore, each woman must be allowed and encouraged to make the decision that is right for her and for her family, including whether to become pregnant or to remain pregnant, according to her own beliefs and conscience.

The proposal you are considering is extreme. SB 23 would ban abortion before many women even know they are pregnant. It interferes with a woman's access to safe healthcare options and unjustly denies her the freedom to make personal, private decisions about her reproductive healthcare. The women of Ohio have the right to make their own conscience-based decisions, including decisions about whether to continue a pregnancy. Bans on abortion serve to shame, judge and punish women who are exercising their conscience to make the best decision for themselves. Arbitrary gestational age limits on abortion disregard women's health and moral agency and they are wrong.

When a woman is denied an abortion, the consequences on her life and her family can be far-reaching. It is not the role of our lawmakers to assign value to a woman's choices, or stymie her moral autonomy but instead to grant her the dignity and respect to follow her conscience and make the choice that is right for her, her health and her family.

Catholics support policies that enable people to make decisions about their future and the future of their families. The majority of the nearly two million Ohio Catholics expect their elected officials to stand up for every individual who will suffer if this legislation is allowed to pass.

We are called as Catholics to advocate for policies that empower the most marginalized in our communities. Whenever bans or other severe restrictions to abortion are enacted, those most negatively affected are women without the resources to access safe care elsewhere, such as those with lower income and those living in rural areas. The principle of social justice which, as Catholics, we are called to model, asks us to stand with those vulnerable women. SB 23 would most adversely affect women already in difficult situations, and therefore we oppose policies, that will disproportionately and unjustly compound the difficulties of families in our communities that are already struggling to make ends meet.

Freedom of belief is a core principle of our American democracy. However, legislation such as SB 23 that would limit access to abortion care has the practical effect of imposing one particular religious belief on all people, which does not reflect the religious freedom protections that are guaranteed to every individual by the Constitution. The proper role of government in the United States is not to privilege one set of religious views over others, but to protect each person's right and ability to make decisions according to their own beliefs and values.

Again, we urge you to oppose extreme legislation, like S 23 and any arbitrary gestational limits on abortion. Such legislation blocks a woman's access to safe healthcare options and unjustly denies her the freedom to make decisions according to her own beliefs and conscience. Instead, we ask that you support policies that show compassion for women and families, no matter their circumstances, and respect for every individual's moral decision-making.
