33 SYNOPSIS

34 **Repeal law blocking public funds if abortion involved**

35 **R.C. 3701.034 (repealed); Section 737. __**

36 Repeals law that requires the Department of Health to
37 ensure that certain federal and state funding is not used to:
38 (1) perform or promote nontherapeutic abortions, or (2) contract
39 with, or become or continue to be an affiliate of, any entity
40 that performs or promotes nontherapeutic abortions.

41 Provides that on the repeal of the limitations described
42 above that any contracts terminated or proposed to be terminated
43 under those limitations must be reinstated or not terminated.

44 **Department of Education**

45 **Sections 265.10 and 265.275**

46 Decreases GRF appropriation item 200597, Program and
47 Project Support, by \$1,000,000 in each fiscal year. Eliminates
48 an earmark of the same amounts for Ohio Adolescent Health
49 Centers to support risk avoidance education initiatives.

50 **Department of Health**

51 **Sections 291.10 and 291.20**

52 Increases both GRF appropriation items 440438, Breast and
53 Cervical Cancer Screening, and 440444, AIDS Prevention, by
54 \$125,000 in each fiscal year. Requires the funds to be
55 distributed to Planned Parenthood affiliates.

56 **Department of Job and Family Services**

57 **Section 307.80**

58 Removes an earmark for the Ohio Parenting and Pregnancy
59 Program for \$3,000,000 in each fiscal year from FED Fund 3V60
60 appropriation item 600689, TANF Block Grant.
