

Chairman Lipps, Vice Chair Holmes, Ranking Member Russo, and Members of the House Health Committee, thank you for the opportunity to provide proponent testimony on House Bill 248. My name is Brittany and I am an RMA as well as a Medical Assisting instructor. The reason I support House Bill 248 is simple, I believe in bodily autonomy and so has most of America when it comes to their own experiences with medical decisions.
