Chairman Lipps, Vice Chair Holmes, Ranking Member Russo, and Members of the House Health Committee, thank you for the opportunity to provide proponent testimony on House Bill 248.

My name is Lee Gillilan and I'm a night mail processing clerk for the United States Postal Service. We have been essential workers from day one of this propaganda virus.
