OIU has made 25,548 visits to liquor permit premises since March 15, 2020. Of those, 4,286 were for Rule 80 or curfew visits (after 10 p.m.). – updated January 6, 2021.

Complaints

OIU has received 1,029 complaints related to health orders since March 15, 2020. – updated January 6, 2021.

Warnings
