Testimony on HB 110 House Finance Health and Human Services Sub-Committee

Chairman Roemer, Ranking Member West, and esteemed committee members:

I want to thank you for giving me the opportunity to testify before you today. My name is Sophia Buckson-Murphy and I am the Program Coordinator of Independence of Portage County, Inc. We are located in Ravenna Ohio and serve Portage County. We are a not for profit business that provides supports for 100+ Ohioans with intellectual and developmental disabilities and we employ 200.

I am very supportive of the budget initiatives outlined by Governor DeWine, Director Davis for the Department of Developmental Disabilities (DODD), and Director Miller for Opportunities for Ohioans with Disabilities (OOD). With these budget initiatives and the leadership of Director Davis, Ohioans with developmental and intellectual disabilities will continue to receive the vital services that organizations like mine provide.

Our services are required for those who are unable to care for themselves. Our individuals often need multiple staff on shift 24/7. They need support to do the most basic of tasks. Things that any typical person might never consider being unable to do. We have people who need full assistance to clean themselves, to eat, to take meds, to stand up, to blow their noses. We also have those who only need assistance with tasks such as attending appointments, money management, med management. Without proper funding, individuals in our community will struggle to complete the most basic of daily living activities. We struggle to provide staffing to support these individuals. Additional investments would ensure that we do not have discontinue services for individuals because we do not have the staffing. If we can provide an adequate wage, the turnover rate for our field may significantly decrease.

To best support these services and the Ohioans who receive and provide them, I encourage you to add the following initiatives into Ohio's biennium budget:


- Increase general revenue fund appropriations in DODD's budget to fund much needed Homemaker and Personal Care, Day and Vocational Services and Nonmedical Transportation Medicaid home and community based waiver services rate increase. *These increases will provide much needed funds for Direct Support Professional (DSP) wages, support for other front-line professionals and sustain the infrastructure necessary to provide our services.*
- Increase general revenue fund appropriations in DODD's budget to support the reimbursement formula for intermediate care facilities (ICF).
- Support a budget amendment that would allow ICFs to choose between a reimbursement rate freeze or a continuation of the formula for the first year of the biennium.
